**ROAD TRAFFIC**

**The M74 Trunk Road (Junction 9 to Junction 11) (Temporary  
30mph Speed Restriction) Order 2024**

*Made* - - - - *5th September 2024*

*Coming into force* - - *8th September 2024*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984<sup>(a)</sup> and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

**Citation, commencement and cessation**

1. This Order may be cited as the M74 Trunk Road (Junction 9 to Junction 11) (Temporary 30mph Speed Restriction) Order 2024, comes into force on 8 September 2024 and ceases to have effect on 30 April 2025.

**Speed restriction**

2. No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of the length of road, specified in the schedule at a speed exceeding 30 miles per hour when a restriction is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign of the type described in item 1 (diagram 670 – maximum speed limit in mph) of the sign table in Part 2 of schedule 10 of the Traffic Signs Regulations and General Directions 2016<sup>(b)</sup>.

## Exemptions

3. No speed restriction imposed by this Order applies to—

- (a) vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011<sup>(a)</sup> when used in accordance with regulation 3(5) of those Regulations, or
- (b) vehicles being used in an emergency for coastguard purposes.

## SCHEDULE

Article 2

### SPECIFIED LENGTH OF ROAD

That length of the M74/A74(M)/A74 Glasgow - Carlisle Trunk Road being the northbound and southbound carriageways from the B7076 Strathaven Road bridge at Junction 9 to the B7078 underbridge at Junction 11 Poniel Interchange, a distance of 10 kilometres or thereby.
