## ROAD TRAFFIC

# The M90/A90 (Finavon Bridge) (Temporary Vehicle Weight Restriction) (No. 2) Order 2024

*Made - - - - 28th November 2024* 

Coming into force - - 6th December 2024

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1), and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

In accordance with section 15(2) of that Act, they are satisfied that the execution of the works will take longer than eighteen months and they will revoke this Order as soon as the works are completed.

#### Citation and commencement

**1.** This Order may be cited as the M90/A90 (Finavon Bridge) (Temporary Vehicle Weight Restriction) (No. 2) Order 2024 and comes into force on 6 December 2024.

#### Weight restriction

2. No person may use, or permit the use of, any vehicle on a length of road, or part or parts of the length of road, specified in the schedule if the maximum gross weight of the vehicle exceeds 44 tonnes when such a restriction is identified as applying to a part or parts of that length of road by means of a traffic sign of the type described in item 13 (diagram 622.1A – goods vehicles exceeding the maximum gross weight indicated prohibited) of Part 2 of schedule 3 of the Traffic Signs Regulations and General Directions 2016(b).

# **Exemptions**

- 3. No prohibition imposed by this Order applies to—
  - (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes, or
  - (b) a vehicle being used for carrying out the works.

### Revocations

**4.** The M90/A90 (Finavon Bridge) (Temporary Vehicle Weight Restriction) Order 2024(a) is revoked.

# **SCHEDULE**

Article 2

# SPECIFIED LENGTH OF ROAD

That length of the M90/A90 Edinburgh – Fraserburgh Trunk Road, Finavon Bridge, in a generally north easterly direction from its junction with the ZU370 access to Boutree Bush, Oathlaw to the B957 access to Tannadice House Finavon, a distance of 0.42 kilometres or thereby.
