# **DECISION AND REASONS**

#### **Introduction**

1. The appellant is a citizen of Ghana, born 19 January 1978. He made an application to the Secretary of State for an EEA residence card. The application was refused in a decision served on 31 May 2016, for reasons that I need not need to set out herein.

#### **Decision of the First-tier Tribunal**

2. The appellant lodged an appeal before the FtT. That appeal came before FtT Judge Scott Baker, who concluded in a decision dated 25 August 2017, that the FtT did not have jurisdiction to determine the appeal. No findings were made in relation to the substance of the appeal. The Judge's conclusion was informed by the guidance given by this Tribunal in <u>Sala</u> [2016] UKUT 00411.

3. The appellant appealed such decision to the Upper Tribunal and FtT Judge Grimmett refused permission, decision dated 3 October 2017.

### Directions made by the Upper Tribunal

- 4. Following a further application to appeal to the Upper Tribunal by the appellant, UT Judge Kebede granted permission, decision dated 20 February 2018. Judge Kebede indicated that the Upper Tribunal was minded to find an error of law, set aside the decision of the First-tier Tribunal and remit the case to the First-tier Tribunal. If either of the parties was opposed to this course they were directed to inform the Tribunal in writing (giving reasons), not later than 7 days from the date the Directions were issued. Following that period, the parties were informed that the Upper Tribunal would issue its decision.
- 5. The Upper Tribunal has not received any correspondence from either party within the stipulated timeframe.

# **Discussion**

- 6. The Court of Appeal has now given consideration to the very issue in play in the instant case - see <u>Khan v Secretary of State for the Home</u> <u>Department</u> [2017] EWCA Civ 1755. The Court concluded that the Upper Tribunal had been wrong in its conclusion and rationale in <u>Sala</u>. It is not in dispute that the effect of the decision in <u>Khan</u>, if applied to this case, is that the First-tier Tribunal was wrong to conclude that it did not have jurisdiction in this appeal.
- 7. For this reason, I set aside the decision of the First-tier Tribunal and remit the appeal back to the First-tier Tribunal to be heard afresh.

# Decision

The decision of the First-tier Tribunal is set aside.

The appeal is remitted to the First-tier Tribunal.
