JUDGMENT

- 1. Upon the respondent's failure to attend this hearing without notice or explanation or response to the contact previously made by this tribunal via post where no telephone or email contact details are known, and the tribunal having waited until after 14:15 before proceeding, it is ordered that the hearing will proceed in the absence of the respondent pursuant to Rule 47, Schedule 1 of the Employment Tribunals (Constitution and Rules of Procedure) Regulations 2013.
