## **JUDGMENT**

**Employment Tribunals Rules of Procedure 2013 - Rule 21** 

- 1. The claim was issued in the Bristol Employment Tribunals on 25/03/2024. The respondent has failed to present a valid response on time. The Employment Judge has decided that a determination can properly be made of the claim, or part of it, in accordance with rule 21 of the Rules of Procedure.
- 2. The respondent has made unauthorised deductions from the claimant's wages and must pay the claimant £959.19.
- 3. The claimant was dismissed in breach of contract in respect of notice and the respondent must pay damages to the claimant of £220.00.
- 4. The respondent has failed to pay the claimant's holiday entitlement and must pay the claimant £513.33 (as a gross sum).
- 5. The respondent must pay the claimant £1,692.52 in total.
