# CONSENT ORDER

## ANNEX A

#### Statement of reasons for consent order

- 1. This appeal concerned the Respondent's Decision Notice under reference FS50450135. That Notice sets out the terms of the original information request at paragraph 6.
- 2. In the said Decision Notice, the Respondent decided that the Appellant had correctly confirmed that information relating to gross profits derived from commercial training is not held. In relation to its decision to withhold information from which the pricing structure of training is derived and details of customers in receipt of training ('the disputed information'), the Commissioner decided that the Appellant wrongly applied the exemptions under sections 43(1) and 43(2) of the Freedom of Information Act 2000 ('the Act').
- 3. The Appellant appealed against the Decision Notice.
- 4. The Respondent now accepts that, in light of the witness evidence served from the Appellant, the disputed information is commercial in nature, that disclosure of that information would be likely to prejudice the Appellant's commercial interests and that, in the circumstances, the public interest in maintaining the exemptions under sections 43(1) and 43(2) of the Act outweighed the public interest in disclosure.
- 5. In view of all the circumstances, the parties jointly submit that it is appropriate for these proceedings to be concluded by way of consent order, and that it is appropriate for the Tribunal to consider their joint application without holding a hearing (as envisaged by rule 37(2)).
