## DECISION

### DETERMINATION

The Tribunal grants dispensation from the consultation requirements contained in section 20 of the Act and the associated Regulations in respect of one contract to be entered into with a registered energy supplier for gas and one for electricity to the common parts of the buildings or other parts of the estates of which the Properties form part, such contracts to be for the period 1<sup>st</sup> October 2015 and terminating on 30<sup>th</sup> September 2018. The purpose of each contract is to enable the registered energy supplier, at the direction of Inenco Limited, to obtain supplies of gas and electricity to such common parts of the buildings or other parts of the estates of which the Properties form part by placing contracts to purchase gas and electricity on the relevant energy markets.

### **Reasons for the Tribunal's determination**

#### Introduction

- 1. On 15<sup>th</sup> July 2014 Trident Social Investment Group applied to the Tribunal ('the Application') for an order under section 20ZA of the Act dispensing with the consultation requirements contained in section 20 of the Act and associated regulations in respect of what were stated to be a portfolio of 3,287 properties located in Birmingham, Sandwell and South Derbyshire. The portfolio includes 9 care homes containing a total of 66 units.
- 2. Section 20ZA (1) and (2) of the Act provides as follows:

'(1) Where an application is made to the appropriate tribunal for a determination to dispense with all or any of the consultation requirements in relation to any qualifying works or qualifying long term agreement, the tribunal may make the determination if satisfied that it is reasonable to do so.'

(2) ....

"qualifying long term agreement" means (subject to subsection (3)) an agreement entered into by or on behalf of the landlord or a superior landlord, for a term of more than twelve months.'

- 3. The Application states that dispensation is required from the Service Charges (Consultation Requirements) (England) Regulations 2003 (SI 2003/1987) ('the Consultation Regulations') in respect of agreements that will fall within the definition of qualifying long terms agreements contained in section 20ZA (2) of the Act that it wishes to enter into with registered suppliers of gas and electricity to serve the common parts of the buildings of which the properties form part.
- 4. The Applicant states in the Application that it is desirous of securing the savings available by bulk buying in the energy market. Energy is a commodity and trades in respect of it are conducted on the LEBA Market. Prices in this market change by the minute and accordingly the Applicant wishes to enter into long term agreements with licensed energy suppliers so that it can secure beneficial prices for the supply of gas and electricity to the properties it is responsible for providing this service to.

5. At the Direction of the Tribunal the Applicant has circularised every person listed in the Application as a respondent with full details of the Application. No objections were received from any person in respect of the proposals or upon the Application.

# **Hearing - Preliminary**

- 6. A Hearing was held at the Tribunal's Hearing suite in Birmingham on 7<sup>th</sup> December 2014. This was attended Ms Anne Twynam of Trident Social Investment Group which, it transpires, is an umbrella organisation with a number of Charities and Companies within it that includes Trident Housing Association Limited. Mr Kevin Jackson also attended on behalf of a company called Inenco Limited, which is assisting with the proposed contract and framework arrangements.
- The Tribunal explained that, from an examination of the sample leases included 7. with the Application it would appear that the Application should have been made by Trident Housing Association Limited, which is the Landlord party to the sample leases. As a result of further discussion, it also transpired that the only parties to whom the duty of consultation exists are those persons who have entered into long leases with Trident Housing Association Limited. The Application had included all of the properties owned by the Housing Association, including all those (by far the majority) which are let on occupational tenancy agreements in respect of which the service charges payable by the tenants are not variable service charges within the definition contained in section 18 of the Act. This is because, although the service charges vary from year to year, there is no balancing at the end of each year, so that in the event that the Housing Association does not collect sufficient from the tenants to cover the cost of providing the services for a given year, it has no power to collect the shortfall from the tenant, and similarly, if there is a collection of more than is required, the tenant is not reimbursed. This is as explained by the Upper Tribunal in Home Group v Lewis [LRX/176/2006] and Chand v Calmore Area Housing Association[LRX/170/2007]. However, it should be noted that in a case where the amount of a service charge payable by a tenant could be varied by the landlord to reflect a surplus or deficit in the income the landlord had previously received, this would satisfy the definition in section 18 of the Act, and would be a variable service charge (Re Southern Housing Group Limited, Re Family Housing Association (Wales) Ltd [2010] UKUT 243 (LC)).
- 8. Following the Hearing a revised schedule of Respondents whose leases or tenancy agreements are subject to the consultation requirements of the Act was provided.
- 9. Under the powers contained in Rule 10 of the Tribunal Procedure (First-tier Tribunal) (Property Chamber) Rules 2013 the Tribunal directs that the Application is amended so that Trident Housing Association Limited is the Applicant and the Respondents are the persons listed in the Schedule to this Decision. The properties which are the subject of the Application ('the Properties) are therefore those listed in the Schedule against the name of each Respondent.

# Hearing - Substantive submissions

10. Mr Jackson explained that what is intended is that the Applicant, through a tender process, enters into two 'framework' agreements with licenced energy suppliers for the provision of gas and electricity to the whole of its portfolio, including all of the buildings of which the individual Properties form part and any shared external areas within each development. These agreements are qualifying long term agreements for the purposes of section 20ZA (2) of the Act. There will also be a separate agreement between the Applicant and Inenco Limited, but this agreement does not require consultation because the amounts payable by each Respondent in respect of it are well below the threshold of £100 per annum per leaseholder.

- 8. Inenco Limited will actively survey the energy markets and direct the registered supplier to acquire units of gas and electricity at beneficial prices. Mr Jackson said that the average saving achieved through the systems it has been operating in recent years is 16%.
- 10. Ms Twynam explained that, in the main, the gas and electricity it supplies is for the common parts of the developments it runs, although in one instance there is communal heating system under which heating is supplied to the individual units of living accommodation in the development.
- 11. It was also explained that the framework agreements will be for three years each, running from 1<sup>st</sup> October 2015 until 30<sup>th</sup> September 2018. It is desired to commence the tendering process for this in January 2015, and accordingly dispensation is requested to enable these agreements to be put in place as soon as possible thereafter. If the consultation procedure has to be entered into it is submitted that there will be insufficient time to have the framework agreements in place to obtain the best prices for gas and electricity within the contract period.
- 12. It is also considered that the contracts for the supply of energy from third parties entered into by the registered energy suppliers under the framework agreements might themselves be caught by the consultation regulations, and it is obviously impracticable to consult on these contracts as they will have to be concluded in minutes.

#### Decision

- 12. The Tribunal agrees that the proposed framework agreements will be qualifying long term agreements for the purposes of section 20ZA (2).
- 13. The Tribunal is satisfied that the proposed arrangements are beneficial for the Respondents and accepts the submissions of the Applicants that the burden of complying with the consultation regulations in respect of the framework agreements would inhibit its ability to conclude these agreements in an efficient manner.
- 13. Accordingly the Tribunal grants dispensation from the consultation requirements in respect of the qualifying long term agreements in the terms set out under the heading 'Determination' at the head of this Decision.

## The Tribunal's Determination

14. If any party is dissatisfied with this decision they may apply for permission to appeal to the Upper Tribunal (Lands Chamber). Any such application must be made within 28 days of this decision (Rule 52 (2)) of The Tribunal Procedure (First-tier Tribunal) (Property Chamber) Rules 2013.
