#### DECISION

#### Decision of the tribunal

The Tribunal orders that the leases to which this application relates be varied as set out in Appendix 2.

#### The application

- 1. The Applicant has applied to the tribunal pursuant to section 35 of the Landlord and Tenant Act 1987 ("the 1987 Act"), for an order that certain leases be varied in the manner set out in Appendix 2.
- 2. The Applicant is the freehold owner of the Property and the Respondents are each the long leaseholder of the flat within the Property listed against their name in Appendix 1.
- 3. The Applicant has commenced some major works at the Property and, having looked into the matter, has concluded that the leases of the flats listed in Appendix 1 have been drafted with inconsistent definitions of "Building" and "Estate". In the Applicant's view, one consequence of these inconsistent definitions is that, when taken together, they result in the service charge proportions failing to add up to 100%, thereby leaving the Applicant with a service charge shortfall. Accordingly, the Applicant applies for the leases to be varied in the manner set out in Appendix 2 in order to remedy this error.

## Paper determination

4. In its application the Applicant stated that it was content for this matter to be dealt with by way of paper determination without an oral hearing. The Tribunal in its directions stated that it proposed to deal with the matter by way of paper determination unless any party requested a hearing. No request has been made for an oral hearing, and accordingly the matter is being dealt with on the papers alone.

## Applicant's case

- 5. The Applicant has provided copies of relevant sample leases, details of its freehold title and details of its proposed variations. In its application it states that the leases have been granted using two different model formats, which it has identified as Type A and Type B.
- 6. The Applicant states that as a result of inconsistent definitions of "Building" and "Estate" in the relevant leases the service charge definition of apportionments does not add up to 100%. The Applicant is of the view that the inconsistent definitions are simply an unfortunate drafting error, and the ground for the application is stated to be section 35(2)(f) of the 1987 Act.

- 7. In a letter dated 19<sup>th</sup> August 2016 the Applicant's solicitors state that a number of the Respondents have contacted them by telephone and by email raising queries and requesting clarification, and they go on to state that these were all addressed.
- 8. The abovementioned letter continues to give an example of an incorrect definition and of its impact. Block 137-243 St Stephens Road comprises the flats with odd numbers between 137 and 243 and contains 54 flats in total. However, the lease for Flat 183 defines "Block" as "ALL THAT block known as 183 to 189 and 237 to 243 St Stephens Road ...", which would suggest that there are 14 flats. The lease for Flat 193, on the other hand, defines "Block" as "ALL THAT block known as 71 to 243 St Stephens Road ...", which would suggest that there are 174 flats. Whereas the lease for Flat 219 defines "Block" as "ALL THAT block known as 137 to 243 St Stephens Road ...", which would suggest that there are 108 flats.
- 9. The costs of service provision are apportioned by reference to the definitions of "Block" and Estate". The costs are to be apportioned equally across all properties in the block and the estate, and consequently the definition needs to reflect the correct number of units within the block and estate to enable reasonable apportionment across all properties. If the Flat 183 definitions were to be used then each leaseholder of Block 137-243 would pay one fourteenth of the costs attributable to that block, whereas if the Flat 193 definitions were to be used then each leaseholder would pay a one hundred and seventy fourth part of the costs attributable to that block.

#### Respondents' responses

- 10. As noted above, the Applicant's solicitors state that a number of the Respondents have contacted them to raise queries and that these queries have all been addressed.
- 11. The only written objections to the application in the bundle are in the form of a letter dated 10<sup>th</sup> August 2016 addressed to the Applicant's solicitors written on behalf of 29 leaseholders. Those objections were then responded to in the letter dated 19<sup>th</sup> August 2016 referred to above. By a letter dated 26<sup>th</sup> August 2016 those leaseholders declared themselves satisfied with the written explanation of the Applicant's solicitors and confirmed that they were now content that the Applicant has justification to vary the wording of the leases.

## The Tribunal's analysis/determination

12. The Applicant refers in the application to there being inconsistent definitions of "Building" and "Estate". In their letter of 19<sup>th</sup> August 2016, the Applicant's solicitors state that there are inconsistent

definitions for "Block" and/or "Estate". However, a perusal of the copy leases in the bundle and of the variations sought seems to indicate that the issue is with the definitions of "Building" and "Demised Premises". That said, it seems clear that the Applicant intended to refer to the definitions of "Building" and "Demised Premises", and these are the terms used in the proposed variations.

- 13. Section 35(1) of the 1987 Act states that "any party to a long lease of a flat may make an application to the appropriate tribunal for an order varying the lease in such manner as is specified in the application". Section 35(2) sets out the grounds on which an application may be made, and the ground set out in section 35(2)(f) is "that the lease fails to make satisfactory provision with respect to … the computation of a service charge payable under the lease".
- 14. Section 35(4) of the 1987 Act states "For the purposes of subsection (2)(f) a lease fails to make satisfactory provision with respect to the computation of a service charge payable under it if (a) it provides for any such charge to be a proportion of expenditure incurred, or to be incurred ... and (b) other tenants of the landlord are also liable under their leases to pay by way of service charges proportions of any such expenditure; and (c) the aggregate of the amounts that would, in any particular case, be payable by reference to the proportions referred to in paragraphs (a) and (b) would either exceed or be less than the whole of any such expenditure".
- 15. The Respondents have been afforded an opportunity to object to the Applicant's analysis and/or to raise queries, and it appears that several have done so. This seems to have resulted in all of the Respondents being satisfied with the Applicant's analysis and conclusions. The bundle contains no evidence of any continuing objections on the part of any of the Respondents and it contains specific evidence that those 29 leaseholders who originally raised objections are now satisfied.
- 16. It is clear from looking at the various definitions of "Building" that there are significant inconsistencies and errors in those definitions. It is also clear, on a sample basis, that some at least of these definitions lead to inconsistent results in respect of service charge apportionment, such that individual leaseholders technically are required to pay very different percentages from each other for no obvious reason. It does seem to be the case that this is simply as a result of drafting errors.
- 17. We note from correspondence that in practice the Applicant has not been applying the strict wording of the leases in relation to service charge computations on the ground, it would seem, that the inconsistent definitions make it unworkable to do so.
- 18. As the parties are in agreement on the point, this is sufficient evidence to enable the Tribunal to conclude that the service charge percentages

add up to less than 100% and that the provisions of section 35(4) are satisfied. In addition, the inconsistent drafting has led to a position of uncertainty for all parties, and therefore for this reason as well we consider that the leases fail "to make satisfactory provision with respect to ... the computation of a service charge payable under the lease" under section 35(2)(f).

- 19. As regards the proposed variations themselves, it is possible that some of these are merely cosmetic. However, in the absence of any objections and as we are satisfied that the case has been made for varying the leases, we consider it sensible to deal with these possibly cosmetic points at the same time.
- 20. Accordingly we order the variation of the leases which are the subject of this application in the manner set out in Appendix 2.

#### **RIGHTS OF APPEAL**

- A. If a party wishes to appeal this decision to the Upper Tribunal (Lands Chamber) a written application for permission must be made to the First-tier Tribunal at the regional office dealing with the case.
- B. The application for permission to appeal must arrive at the regional office within 28 days after the Tribunal sends written reasons for the decision to the person making the application.
- C. If the application is not made within the 28 day time limit, such application must include a request for extension of time and the reason for not complying with the 28 day time limit; the Tribunal will then look at such reason and decide whether to allow the application for permission to appeal to proceed despite not being within the time limit.
- D. The application for permission to appeal must identify the decision of the Tribunal to which it relates (i.e. give the date, the property and the case number), state the grounds of appeal, and state the result the party making the application is seeking.
