Nature of Complaint

The Information Commissioner (the "Commissioner") has received a complaint which states that on 3rd January 2005 the following information was requested from the Home Office under section 1 of the Freedom of Information Act 2000 (the "Act"):

"all internal policy documents and communication traffic (emails and other documents) concerning changes in the implementation of immigration rules- those specifically regarding the BRACE exercises and any other backlog reduction or clearance exercises, the ECAA caseload and student and marriage work streams (all these from 2002 onwards) – and those between officials and between officials and ministers discussing presentation to the media from March 7 up to present".

The Home Office did not respond to the complainant's request of 3rd January 2005 until 19th September 2005. It is alleged that the Home Office failed to respond to the complainant's request within the twenty working day period for a response to a request for information made under section 1, prescribed by section 10 of the Act.

Section 10(1) of the Act states -

"...a public authority must comply with section 1(1) promptly and in any event not later than the twentieth working day following the date of receipt."



The Duty of the Commissioner under section 50

Under section 50(1) of the Act any person may apply to the Commissioner for a decision whether his request for information made to a public authority has been dealt with in accordance with the requirements of Part 1 of the Act.

Under section 50(2) of the Act, except where a complainant has failed to exhaust a local complaints procedure, or where the complaint is frivolous or vexatious, subject to undue delay, or has been withdrawn, the Commissioner is under a duty to make such a decision as referred to in section 50(1).

Under section 50(3) of the Act the Commissioner shall either notify the complainant that he has not made a decision or serve a notice of his decision on both the complainant and the public authority.

The Commissioner's Decision

The Commissioner's decision in this case is that the Home Office has not dealt with the complainant's request in accordance with the requirements of Part 1 of the Act in that it has failed to comply with:

Section 10(1) – in that it exceeded the statutory time limit for responding to a request made under section 1.

Action Required

The Information Commissioner has advised the Home Office how it should comply with the statutory time limits in relation to requests for information it may receive in the future.

The Home Office responded to the complainant's request on 19th September advising that the requested information would not be provided as the cost of supply would exceed the prescribed limit and suggesting that the complainant refine his request so that it might fall within the prescribed costs limit. The complainant has responded to the Home Office suggestion that he refine his request in an email dated 27th September 2005.



Right of Appeal

Either party has the right to appeal against this Decision Notice to the Information Tribunal (the "Tribunal"). Information about the appeals process can be obtained from:
