

# Freedom of Information Act 2000 (FOIA) Decision notice

Date: 9 February 2012

### Decision (including any steps ordered)

- 1. The complainant has requested some information about the meetings of transition trustees and connected data. He received no response.
- 2. The Commissioner gave British Waterways a number of opportunities to issue an appropriate response and it failed to do so.
- 3. The Commissioner's decision is that British Waterways has breached the requirements of section 1(1) in not issuing an appropriate response. It has also breached section 10(1) of FOIA because it has not complied with section 1(1) within 20 working days.
- 4. The Commissioner requires British Waterways to take the following steps to ensure compliance with the legislation:
  - Confirm or deny whether it holds relevant recorded information for each remaining part of the request;
  - Either disclose all the information, or disclose the non-exempt information and explain for each piece of withheld information which exemption it is applying and why it considers that it applies. Should it apply an exemption with a public interest component – it should explain the factors that it has taken into account and why the public interest favours the maintenance of the exemptions in all the circumstances of the case.
- 5. It should undertake these steps on the What Do They Know website as requested by the complainant.



6. British Waterways must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the FOIA and may be dealt with as a contempt of court.

## Request and response

7. On 2 September 2011 the complainant requested the following information:

'I note that BW has no policy under the freedom of information act for proactively publishing minutes of meetings of the transition trustees who were appointed over three months ago.

[1] Please supply via Whatdotheyknow.com all minutes, notes or action lists from these meetings and any meetings of sub committees formed by the trustees.

[2] Please also provide copies of any reports or documents mentioned in the minutes (or notes or action lists).

I confirm that my request includes draft minutes in cases where they have not been approved or agreed.

- [3] Also provide terms of reference for any subcommittees formed.'
- 8. After several reminders, British Waterways acknowledged the request on 26 September 2011.
- 9. No further response was received by the date of this Notice.

#### Scope of the case

- 10. The complainant contacted the Commissioner to complain about the way his request for information had been handled.
- 11. He agreed that the Commissioner would issue a decision notice to compel British Waterways to issue an appropriate response.



#### Reasons for decision

12. Section 1(1) of FOIA imposes obligations on public authorities to answer requests for information that they have received. It states:

'Any person making a request for information to the public authority is entitled —

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request; and
- (b) if that is the case, to have that information communicated to him.'
- 13. However there are various exemptions in FOIA that allow the public authority to be excluded from these obligations in certain circumstances.
- 14. As British Waterways has not issued a response it has not complied with section 1(1) of FOIA.
- 15. FOIA also has a number of procedural provisions that are designed to enable a complainant to receive an appropriate response (that can be understood) in good time.

Section 10(1)

- 16. Section 10(1) of FOIA requires that a public authority complies with section 1(1) promptly and in 20 working days at the latest.
- 17. British Waterways failed to issue any response within 20 working days and therefore breached section 10(1).



## Right of appeal

18. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
