

Freedom of Information Act 2000 (FOIA) Decision notice

Date: 9 February 2012

Decision (including any steps ordered)

- 1. The complainant asked British Waterways for all the information mentioned in the 23 November 2011 Board Meeting minutes and the agenda and minutes of that meeting. He received no response.
- 2. The Commissioner's decision is that British Waterways has breached the requirements of section 1(1) in not issuing an appropriate response. It has also breached section 10(1) of FOIA because it has not complied with section 1(1) within 20 working days.
- 3. The Commissioner requires British Waterways to take the following steps to ensure compliance with the legislation:
 - Confirm or deny whether it holds relevant recorded information for each remaining part of the request;
 - Either disclose all the information, or disclose the non-exempt information and explain for each piece of withheld information which exemption it is applying and why it considers that it applies. Should it apply an exemption with a public interest component – it should explain the factors that it has taken into account and why the public interest favours the maintenance of the exemptions in all the circumstances of the case.
- 4. It should undertake these steps on the What Do They Know website as requested by the complainant.
- 5. British Waterways must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court



pursuant to section 54 of the FOIA and may be dealt with as a contempt of court.

Request and response

- 6. The complainant made the same request for the requested information before the relevant meeting occurred.
- 7. On 22 December 2011 the complainant requested the following information:

'I refer to the board meeting held on 23/11/2011.

Can you please provide via whatdotheyknow.com a copy of all reports, sub committee minutes and other documents mentioned in the minutes of this meeting.

Can you also provide a copy of the minutes and agenda, unless these have already been published on your website.

May I ask that you give full reasons (quoting the relevant section of the FoI Act) for any redacted information.'

8. No response was received by the date of this Notice.

Scope of the case

- 9. The complainant contacted the Commissioner to complain about the way his request for information had been handled.
- 10. He agreed that the Commissioner would issue a decision notice to compel British Waterways to issue an appropriate response.

Reasons for decision

11. Section 1(1) of FOIA imposes obligations on public authorities to answer requests for information that they have received. It states:

'Any person making a request for information to the public authority is entitled –



- a. to be informed in writing by the public authority whether it holds information of the description specified in the request; and
- b. if that is the case, to have that information communicated to him.'
- 12. However there are various exemptions in FOIA that allow the public authority to be excluded from these obligations in certain circumstances.
- 13. As British Waterways has not issued a response it has not complied with section 1(1) of FOIA.
- 14. FOIA also has a number of procedural provisions that are designed to enable a complainant to receive an appropriate response (that can be understood) in good time.

Section 10(1)

- 15. Section 10(1) of FOIA requires that a public authority complies with section 1(1) promptly and in 20 working days at the latest.
- 16. British Waterways failed to issue any response within 20 working days and therefore breached section 10(1).



Right of appeal

17. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
