

# Freedom of Information Act 2000 (FOIA) Decision notice

#### Decision (including any steps ordered)

- 1. The complainant requested various information concerning the operation of West Felton Parish Council (the Council). The Council did not provide a valid response to these requests.
- 2. The Commissioner's decision is that the Council has breached sections 1 and 10 of the FOIA in that it failed to provide a valid response to the requests within 20 working days of receipt.
- 3. The Commissioner requires the Council to take the following steps to ensure compliance with the legislation.
  - Provide a response to the requests that complies with section 1 of the FOIA. This response should, unless a provision removing that obligation is claimed, confirm or deny whether recorded information falling within the scope of each of the requests is held. In relation to any information that is held, this should either be disclosed, or reasoning valid for the purposes of the FOIA should be given as to why this information will not be disclosed.
- 4. The public authority must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.



#### **Request and response**

- 5. The complainant made a number of information requests to the Council on 4 April 2012, 4 July 2012 and 3 August 2012. For the sake of brevity here these requests are set out in a separate annex.
- 6. Whilst there was some subsequent correspondence between the complainant and the Council, the complainant did not receive a valid response to his information requests.

#### Scope of the case

7. The complainant contacted the Commissioner on 12 May 2012 to complain about the failure to provide a valid response to his requests for information. The complainant contacted the Commissioner again following this to complain about the failure to respond to information requests that were made later than this. These later requests were accepted within the scope of this case.

#### **Reasons for decision**

#### Sections 1 and 10

- 8. Sections 1 and 10 of the FOIA provide that a public authority is obliged to respond to an information request within 20 working days of receipt with confirmation or denial of whether the requested information is held. For any information that is held, this should either be disclosed, or the public authority should give reasoning valid under the FOIA as to why it will not be disclosed.
- 9. In this case the Council failed to provide a response to the requests that complied with these requirements. In so doing it breached sections 1 and 10 of the FOIA. At paragraph 3 above the Council is now required to provide a response to these requests that is valid for the purposes of the FOIA.

#### **Other matters**

10. When presenting its position in this case the Council focussed on the background to these requests. Whilst the Commissioner appreciates that this background may be fraught, and also appreciates that Parish Councils often do not have the resources of larger public authorities, the



Council is nonetheless required to comply with the requirements of the FOIA.

11. Where a public authority is concerned about the impact of a request upon it, the FOIA has provision for a request to be refused on cost grounds under section 12, or as vexatious under section 14. Both of these provisions, however, require that the requester is provided with a written response explaining why their request is refused. ### **Right of appeal**

12. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:

4 April 2012	Draft minutes are no longer being distributed in accordance with the policy agreed by the Parish Council in minute 7.6 of its meeting on 17 May 2007. Please provide me with details of the authority given for such changes.
4 April 2012	Reasons for decisions taken are not being consistently published and/or substantiated in the minutes of Parish Council meetings. Please inform me as to the authority and reasons for such omissions.
4 July 2012	Please provide me with copies of the following documents in relation to the [2011 – 12] Annual Return:
	Section 2 – Annual Governance Statement.
	Section 4 – Annual Internal Audit Report.
	Explanation of Variances proforma.
3 August 2012	I refer to draft minute 121/12 of the Parish Council meeting held on 26 July 2012. Please provide me with specific substantiating information including dates and any relevant copy documents relating to the accusations made against those referred therein of ' <i>intimidation from a particular source'</i> .
