Freedom of Information Act 2000 (FOIA) Decision notice

Decision (including any steps ordered)

1. The complainant has requested information relating generally to the use of 084 numbers in the NHS. The Commissioner's decision is that NHS Luton breached section 10(1) of FOIA by providing its response outside of the statutory time limit of 20 working days. The Commissioner does not require NHS Luton to take any action as a result of this notice.

Request and response

2. On 5 May 2012 the complainant wrote to NHS Luton and requested information in the following terms:

"[...]

I wish to make a Freedom of Information Act request for all documents that you hold:

- relating to your contract with the Medici Medical Practice and any correspondence with it over 0844 numbers, and
- relating to the use of 084 numbers in the NHS, including documents issued by the Department of Health, and your correspondence on the subject with local practices and the Luton and Dunstable Hospital (which still uses some 084 numbers)."

3. On 16 May 2012 NHS Luton acknowledged the request, confirming that it had been received on 10 May 2012.

- 4. The complainant contacted the Information Commissioner on 27 June 2012 to bring to his attention the failure of NHS Luton to respond to his request. Following the involvement of the Commissioner, and it seems further reminders from the complainant, NHS Luton provided its substantive response on 30 August 2012.
- 5. The complainant contacted NHS Luton again later the same day and advised that it had not enclosed all of the relevant papers associated with the request. This information was subsequently received from NHS Luton on 22 October 2012.

Scope of the case

6. The complainant contacted the Commissioner on 6 November 2012 to ask the Commissioner to record the failure of NHS Luton to comply with the procedural requirements of FOIA in its handling of the request.

Reasons for decision

- 7. Section 10(1) of FOIA states that on receipt of a request for information a public authority should respond to the applicant within 20 working days.
- 8. In this case NHS Luton acknowledged receipt of the request but did not manage to provide its response within the statutory timeframe. The Commissioner has therefore found that it breached section 10(1) of FOIA.
