

# Freedom of Information Act 2000 (FOIA)

### **Decision notice**

**Date:** 7 April 2014

**Public Authority:** The Cabinet Office

Address: 70 Whitehall

London SW1A 2AS

## **Decision (including any steps ordered)**

- 1. The complainant has requested information about the use of personal electronic equipment, the use of Wifi and the associated policies within Cabinet Office premises. By the date of this notice the Cabinet Office had yet to provide a substantive response to this request. The Information Commissioner's decision is that the Cabinet Office breached section 10 of the FOIA in that it has failed to provide a response to the request.
- 2. The Commissioner requires the Cabinet Office to take the following steps to ensure compliance with the legislation:
  - Issue a response to the request under the FOIA by either complying with section 1(1) or issuing a valid refusal notice.
- 3. The public authority must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.



### **Request and response**

4. On 21 October 2013, the complainant wrote to the Cabinet Office and requested information in the following terms:

"Having read press articles during the last week about Francis Maude having a wifi network installed in his office could you please provide me with the following information:

- 1. Current policy, or policies, regarding the use of wifi equipment within official Cabinet Office premises.
- 2. Current policy, or policies, regarding the use of personal electronic devices (including mobile phones and tablets) within official Cabinet Office premises.
- 3. Any security threat assessments or information loss risk assessments that relate to the installation of the specific wifinetwork referred to in the press articles".
- 5. The complainant received an acknowledgement from the Cabinet Office on 22 October 2013.
- 6. Having heard nothing further, the complainant sent a further email to the Cabinet Office on 26 November 2013 and in the absence of any communication, sent a request for an internal review on 29 November 2013.

#### Scope of the case

- 7. The complainant contacted the Commissioner on 24 January 2014 to complain about the way his request for information had been handled. He specifically asked the Commissioner to consider the fact that no substantive response had been provided.
- 8. The Commissioner wrote to the Cabinet Office on 31 January 2014 asking for a response to be issued within 10 working days. In the absence of any response the Commissioner contacted the Cabinet Office again on 25 February 2014 and was advised that a response would be issued the following day. No response was issued and the Commissioner wrote again to the Cabinet Office on 11 March 2014 advising that the complaint would be investigated.
- 9. No substantive response to the request had been provided by the date of this notice.



#### Reasons for decision

- 10. Section 1(1) of FOIA states that:
  - 1(1) Any person making a request to a public authority is entitled -
  - (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
  - (b) if that is the case, to have that information communicated to him.
- 11. Section 8(1) of FOIA states:
  - 8(1) In this Act any reference to a "request for information" is a reference to such a request which
    - (a) is in writing,
    - (b) states the name of the applicant and an address for correspondence, and
    - (c) describes the information requested.
- 12. The Commissioner considers that the request in question fulfilled these criteria, and therefore constituted a valid request for recorded information under the FOIA.
- 13. Section 10(1) of the FOIA states that a public authority must comply with section 1(1) promptly and in any event not later than the twentieth working day following the date of receipt.
- 14. From the information provided to the Commissioner it is evident that the Cabinet Office did not respond to the complainant within the statutory timeframe in respect of this request.
- 15. The Commissioner's decision is that the Cabinet Office did not deal with the request for information in accordance with the FOIA. It breached section 10(1) of the FOIA by failing to provide a substantive response to the request within the statutory timeframe of 20 working days. As it has still not responded to the request, the Cabinet Office is now formally required by the Commissioner to respond to the request of 21 October 2013.



# Right of appeal

16. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
