# Freedom of Information Act 2000 (FOIA) Decision notice

## **Decision (including any steps ordered)**

- 1. The complainant has made a request to Darlington Borough Council ("the council") for information relating to the Dolphin Centre. The council responded outside the time for compliance provided by section 10(1) of the Freedom of Information Act ("the FOIA").
- 2. The Commissioner's decision is that the council has breached the requirement of section 10(1).
- 3. The Commissioner does not require any steps to be taken.

## **Request and response**

4. On 16 June 2014, the complainant wrote to the council and requested the following:

"Please could I request the following about the dolphin centre (DC) under the FoI Act 2000?

- 1, Is the Council the license holder or is the bar at the Dolphin Centre sub let? Please provide details of the licence holder?
- 2, Please can I have a copy of the bar tariff/price list? In the event there are different price lists for different events ie: weddings please provide all price lists with a list of which goes with each event?

- 3, If the bar is ran by the LA who much did it cost to run last year? (to include staff and rent figures if applicable).
- 4, If it is sub let what is the yearly rent?
- 5, If it is council ran what were the last 3 financial years gross and net profits?
- 6, Is the DC bar/license subject to any LA restrictions if so please provide copys?
- 7, If the DC bar is ran by the council please provide an exact financial breakdown of where the last 3 financial years profits have gone/been used for?"
- 5. The council provided a substantive response on 18 July 2014.

#### Scope of the case

- 6. The complainant contacted the Commissioner on 28 November 2014 to complain about the way his request for information had been handled.
- 7. The Commissioner considers the scope of this case is the determination of whether the council has complied with section 10(1).

#### Reasons for decision

## **Section 10(1) – Time for compliance**

- 8. Section 10(1) requires that a public authority must issue substantive response within the time for compliance, which is 20 working days following the date on which the request is received.
- 9. In this case the Commissioner has identified that the council issued its response outside 20 working days, and therefore breached the requirement of section 10(1).
