# Freedom of Information Act 2000 (FOIA)

### **Decision notice**

### **Decision (including any steps ordered)**

- 1. The complainant has requested information about a police operation carried out on taxi and private hire drivers from the Metropolitan Police Service (the "MPS"). To date he has not received a substantive response. The Commissioner's decision is that the public authority has failed to provide a response to the request within the statutory time frame of 20 working days. He requires it to comply with the request or issue a valid refusal notice as set out in section 17 of the FOIA.
- 2. The MPS must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.

#### Request and response

3. On 4 March 2015, the complainant wrote to the MPS and requested information in the following terms:

"I understand that the Police carried out operations on Taxi and Private Hire Divers on the weekend of 27, 28 February and 1 March 2015 for badge and bill checks. Could you kindly supply the figures for this and break them down into the following Private Hire Drivers licensed, non licences drivers i.e. members of public, Taxi drivers,

Limo Drivers. In the licences vehicles stopped how many had passengers.

What was the purpose of the enforcement."

4. The MPS acknowledged receipt of the request.

### Scope of the case

- 5. On 22 May 2015 the complainant contacted the Commissioner to complain about the lack of response by the MPS to his request for information.
- 6. The Commissioner wrote to the MPS on 26 May 2015 asking it to respond to the complainant within 10 working days.

#### Reasons for decision

## **Section 10 – time for compliance**

- 7. The Commissioner considered whether the MPS has responded to the request of 4 March 2015 in line with the provisions of the FOIA.
- 8. Despite the intervention of the Commissioner, the MPS has still not responded to the complainant's request for information.
- 9. Section 10(1) of the FOIA states that on receipt of a request for information a public authority should respond to the applicant within 20 working days. From the information provided to the Commissioner in this case it is evident that the MPS did not respond to the complainant within the statutory time frame and so it is in breach of section 10(1) of the FOIA.

#### Other matters

10. The delay in responding to this request will be logged as part of ongoing monitoring of the MPS's compliance with the FOIA.
