

## Freedom of Information Act 2000 (FOIA)

### Decision notice

**Date:** 26 January 2016

**Public Authority:** Home Office  
**Address:** 2 Marsham Street  
London

#### Decision (including any steps ordered)

---

1. The complainant requested a list of film or television projects that the Home Office had communicated with during 2013 to 2015. The Home Office failed to respond to this request.
2. The Commissioner's decision is that the Home Office breached sections 1(1) and 10(1) of the FOIA by failing to respond to this request within 20 working days of receipt. The Home Office is now required to respond to the request.
3. The Commissioner requires the Home Office to take the following steps to ensure compliance with the legislation.
  - Respond to the request.
4. The Home Office must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the FOIA and may be dealt with as a contempt of court.

#### Request and response

---

5. On 6 October 2015 the complainant wrote to the Home Office and requested information in the following terms:

*"I understand there has been communication between the Home Office and film/TV drama projects concerning advice on storylines relating to terrorism investigations or storylines set within the Muslim community. I would like a list of film/TV projects the Home Office has communicated with during the period of 2013-15."*

6. The Home Office did not respond to this request.

### **Scope of the case**

---

7. The complainant contacted the Commissioner on 9 December 2015 to complain about the failure by the Home Office to respond to his information request.
8. The Commissioner contacted the Home Office on 5 January 2016 and asked it to respond to the request within 10 working days. The Home Office did not respond.

### **Reasons for decision**

---

#### **Sections 1 and 10**

9. Section 1(1) of the FOIA states that an individual who asks for information is entitled to be informed whether the information is held and, if the information is held, to have that information communicated to them. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and *"not later than the twentieth working day following the date of receipt"*.
10. In this case the Home Office has breached sections 1(1) and 10(1) by failing to respond substantively to the request within 20 working days. At paragraph 3 above the Home Office is now required to respond to the complainant's request in accordance with the FOIA.

#### **Other matters**

---

11. As well as issuing this notice, the Commissioner has made a separate record of the failure by the Home Office to respond to the complainant's request. This issue may be revisited should evidence from other cases suggest that this is necessary.

## Right of appeal

---

12. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
