Decision (including any steps ordered)

- 1. The complainant has requested information relating to the salary of a particular individual. The Trust has failed to respond to this request for information.
- 2. The Commissioner considers that the Trust breached section 10(1) FOIA in the handling of this request.
- 3. The Commissioner requires the public authority to take the following steps to ensure compliance with the legislation.
 - The Trust must provide the complainant with a response to this request in accordance with its obligations under FOIA.
- 4. The public authority must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.

Request and response

5. On 14 October 2016 the complainant made the following request to East London Health Trust:

"I would like to find what salary or rates of pay is currently being paid to Ian Miller, Financial Turnaround Director or his affiliated company Maxentius. If he or his affiliated company Maxentius are no longer Reference: FS50662024



employed by the trust, I would also like to know the duration and pay of his/their employment."

6. The Trust has not provided a response to this request.

Scope of the case

- 7. The complainant contacted the Commissioner on 5 January 2017 to complain about the way his request for information had been handled.
- 8. The Commissioner has considered whether the Trust dealt with this request in accordance with its obligations under section 10(1) FOIA.

Reasons for decision

9. Section 10(1) provides that:

"Subject to subsections (2) and (3), a public authority must comply with section 1(1) promptly and in any event not later than the twentieth working day following the date of receipt."

10. Section 1(1) provides that:

"Any person making a request for information to a public authority is entitled —

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and (b) if that is the case, to have that information communicated to him."
- 11. The request was made on 14 October 2016 and a response is yet to be provided. The Commissioner therefore finds that the Trust breached section 10(1) in failing to respond within 20 working days.
