

Freedom of Information Act 2000 (FOIA) Decision notice

Date: 22 June 2017

Public Authority: Ministry of Justice Address: 102 Petty France

SW1H 9AJ

Decision (including any steps ordered)

- 1. The complainant has requested information regarding fines for G4S relating to the running of prisons since April 2016.
- 2. The Ministry of Justice (MoJ) failed to respond to this request for information and the Commissioner's decision is that the MoJ has breached section 10(1) of the FOIA.
- 3. The Commissioner requires the public authority to take the following steps to ensure compliance with the legislation.
 - The MoJ must provide the complainant with a response to this request in accordance with its obligations under the FOIA.
- 4. The public authority must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.

Request and response

5. On 11 January 2017, the complainant wrote to the MoJ and requested information in the following terms:



- "- From April 2016 to date, has the MoJ fined G4S (/applied "performance point financial deduction amounts" to G4S/ asked G4S to make "financial remedy") for its running of prisons?
- Please provide a table of fines from April 2016 to date broken down by the name of the prison eg HMP Birmingham/HMP Oakwood, specify the date of the fine and a description of what the fine was for and when eg if it was for failure to comply with Contract Delivery Indicators, please specify what CDI eg presence of psychoactive substances and please name the substances where appropriate
- If the fines are broken down by quarter in the table you provide I believe they are applied in the proceeding quarter please also state the total payment to G4S for the running of the prison in the same quarter
- In the same table broken down by the name of each prison G4S runs, please give a description of what repairs G4S has had to carry out to date. Please specify when those repairs were carried out, describe the damage that prompted the repairs and when that damage was caused and state what those repairs cost G4S and the MoJ respectively.
- Please provide the aforementioned information in a Microsoft Excel spreadsheet."
- 6. The MoJ responded to acknowledge the request on 12 January 2017.
- 7. The complainant has chased up his request for information numerous times since 14 February 2017.
- 8. At the date of this decision notice, the MoJ had yet to provide a substantive response.

Scope of the case

- 9. The complainant contacted the Commissioner on 10 March 2017 to complain about the way his request for information had been handled.
- 10. The Commissioner considers the scope of this decision notice to be the MoJ's compliance with section 10(1) of the FOIA.



Reasons for decision

- 11. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and "no later that the twentieth working day following the date of receipt".
- 12. The Commissioner wrote to the MoJ on 4 May 2017 and asked it to respond to the complainant's request within 10 working days. The MoJ responded to the Commissioner on 17 May 2017 and said it hoped to send a response to the complainant soon.
- 13. In this case the MoJ has breached section 10(1) by failing to respond to the request within 20 working days.

Other matters

14. As well as finding above that the MoJ is in breach of the FOIA, the Commissioner has also made a record of the delay in this case. This may form evidence in future action against the MoJ should evidence from other cases suggest that there are systemic issues within the MoJ that are causing delays.



Right of appeal

15. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
