Decision notice

Decision (including any steps ordered)

- 1. The complainant has requested information relating to a "two-day retreat" event which was held for the leads of England's 44 Sustainability and Transformation Plan (STP) footprint areas to discuss next steps in the STP process. NHS England has failed to respond to this request.
- 2. The Commissioner considers that the NHS England breached section 10(1) FOIA in the handling of this request.
- 3. The Commissioner requires the public authority to take the following steps to ensure compliance with the legislation.
 - NHS England must provide the complainant with a response to this request in accordance with its obligations under FOIA.
- 4. The public authority must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.

Request and response

5. On 17 February 2017 the complainant made the following request to NHS England:



"At the end of January a "two-day retreat" event was held for the leads of England's 44 Sustainability and Transformation Plan footprint areas to discuss next steps in the STP process.

See page 16:

"To kick start this, a two day retreat has been arranged for the 44 STP leads with the national CEOs at the end of January to discuss next steps."

Please provide me with:

A copy of the agenda and schedule for this event.

The venue of this event, which of the STP leads attended, who else was there and a list of any speakers.

A breakdown of all the full costs of the event, ie how much was spent on venue hire, travel etc and by which organisation/s.

A list of any costs which were covered by private sector organisations, including which organisations they were and the amounts.

A list of any outside organisations, including private companies, which participated in the two-day event, stating what their involvement was ie "presentation by Deloitte on NHS efficiency" etc.

A list of any formal decisions taken at the event with regards to the STP process."

6. NHS England has not responded to this request.

Scope of the case

- 7. The complainant contacted the Commissioner on 20 March 2017 to complain about the way his request for information had been handled.
- 8. The Commissioner has considered whether NHS England dealt with this request in accordance with its obligations under section 10(1) FOIA.

Reasons for decision

9. Section 10(1) provides that:



"Subject to subsections (2) and (3), a public authority must comply with section 1(1) promptly and in any event not later than the twentieth working day following the date of receipt."

10. Section 1(1) provides that:

"Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and (b) if that is the case, to have that information communicated to him."
- 11. The request was made on 17 February 2017 and a response has not yet been provided. The Commissioner therefore finds that NHS England breached section 10(1) in failing to respond within 20 working days.



Right of appeal

12. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from: First-tier Tribunal (Information Rights)
