

Freedom of Information Act 2000 (FOIA) Decision notice

Date: 19 September 2017

Public Authority: Home Office

Address: 2 Marsham Street

Decision (including any steps ordered)

- 1. The complainant has requested information from the Home Office regarding correspondence between any Lancashire business and the Home Office relating to anti-fracking protests near Preston and any resulting correspondence between the Home Office and Lancashire Police.
- 2. The Commissioner's decision is that the Home Office has breached section 10(3) of the FOIA as it has failed to give a substantive response to this request within a reasonable timeframe.
- 3. The Commissioner requires the public authority to take the following steps to ensure compliance with the legislation.
 - The Home Office must issue a substantive response to the request in accordance with its obligations under the FOIA.
- 4. The public authority must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.



Request and response

5. On 13 March 2017, the complainant wrote to the Home Office via whatdotheyknow.com and requested information in the following terms:

"A report in The Times on 11 March 2017 about opposition to a fracking drill site near Blackpool stated that "after complaints to the Home Office by local pro-business leaders, Lancashire Police are taking a tougher line with the protesters, some of whom are anti-capitalist activists."

Please can you provide copies of correspondence between any Lancashire business organisations and the Home Office regarding the protests at Preston New Road since the start of January and any subsequent or resulting correspondence between the Home Office and Lancashire Police?"

- 6. The Home Office acknowledged the request on the same day. It stated that it aimed to give a full response by 11 April 2017.
- 7. On 11 April 2017 the Home Office issued a letter to the complainant stating:

"The information which you have requested is being considered under the exemptions in Section 31 and Section 35 of the Act, which relate to law enforcement and formulation of Government policy. These are qualified exemptions and to consider the public interest test fully we need to extend the 20 working day response period. We now aim to let you have a full response by 12 May 2017."

Scope of the case

- 8. The complainant contacted the Commissioner on 1 June 2017 to complain about the way his request for information had been handled.
- 9. Following receipt of the complaint the Commissioner contacted the Home Office, reminding it of its responsibilities and asking it to respond to the complainant within 10 working days.
- 10. Despite this intervention the Home Office has failed to respond to the complainant.



Reasons for decision

- 11. Section 10(1) of the FOIA states that an authority must comply with section 1(1) of the FOIA '...promptly and in any event not later than the twentieth working day following the date of receipt'. However, section 10(3) enables an authority to extend the 20 working day limit up to a 'reasonable' time in any case where the public interest test attached to the application of a qualified exemption is being considered.
- 12. The FOIA does not define what constitutes a 'reasonable' extension of time. It is the view of the Commissioner however that an authority should normally take no more than an additional 20 working days to consider the public interest test, meaning that the total time spent dealing with the request should not exceed 40 working days.
- 13. The Commissioner has found that the time taken to produce a substantive response to the request considerably exceeds the 40 working days and is therefore not reasonable. She has therefore decided that the Home Office has breached section 10(3) of the FOIA.



Right of appeal

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
