

## Freedom of Information Act 2000 (FOIA)

### Decision notice

**Date:** 19 June 2018

**Public Authority:** Home Office  
**Address:** 2 Marsham Street  
London  
SW1P 4DF

#### Decision (including any steps ordered)

---

1. The complainant requested information from the Home Office about cases where citizenship nullification is under review.
2. The Commissioner's decision is that the Home Office has breached section 10(1) of the FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
3. The Commissioner requires the Home Office to take the following steps to ensure compliance with the legislation.
  - The Home Office must issue a substantive response to the request in accordance with its obligations under the FOIA.
4. The Home Office must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.

## Request and response

---

5. On 31 January 2018, the complainant wrote to the Home Office and requested information in the following terms:

*"Following the judgment of the Supreme Court in Hysaj in December 2017 I understand that the Home Office has been writing to individuals whose British citizenship has previously been nullified stating that the decision to nullify in their case is now under review.*

*I would like to know:*

- 1. How many cases of previous citizenship nullification are now under review?*
  - 2. So far, in how many reviewed cases has a decision been taken to commence deprivation action instead?*
  - 3. What criteria or policy is being applied in these cases?*
  - 4. If possible, a breakdown by year of past nullification decisions. For example, how many nullification decisions were made in each of the following years: 2007, 2008, 2009, 2010, 2011, 2012, 2013, 2014, 2015, 2016 and 2017?*
  - 5. How many Home Office staff have been allocated to this review?"*
6. The Home Office acknowledged the request on 1 February 2018. On 20 February 2018, 20 working days after having received the request, it informed the complainant it was unable to provide a response within the statutory time frame and apologised for the delay.
7. The complainant wrote to the Home Office on 22 March 2018 to request a review into the failure to provide a response. On 18 April 2018 the Home Office provided its review in which it acknowledged that it had breached section 10(1) of the FOIA. It confirmed that a response had been drafted and was going through clearance.
8. The complainant wrote to the Home Office again on 23 May 2018 to chase the response. To date, a substantive response has not been provided.

## Scope of the case

---

9. The complainant contacted the Commissioner on 13 April 2018 to complain about the Home Office's failure to provide a response to his request.
10. On 25 May 2018 the Commissioner wrote to the Home Office, reminding it of its responsibilities and asking it to provide a substantive response to the complainant within 10 working days.
11. Despite this intervention the Home Office has failed to respond to the complainant.

## Reasons for decision

---

12. Section 1(1) of the FOIA states that:

*"Any person making a request for information to a public authority is entitled –*

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and*
- (b) if that is the case, to have that information communicated to him."*

13. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and *"not later than the twentieth working day following the date of receipt."*
14. From the evidence provided to the Commissioner in this case, it is clear that the Home Office did not deal with the request for information in accordance with the FOIA. The Commissioner finds that the Home Office has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with the FOIA.

## Right of appeal

---

15. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
