

Freedom of Information Act 2000 (FOIA) Decision notice

Date: 9 August 2018

Public Authority: Home Office

Address: 2 Marsham Street

Decision (including any steps ordered)

- 1. The complainant requested information from the Home Office about the relationship between immigration removal targets and Senior Civil Service pay performance measures.
- 2. The Commissioner's decision is that the Home Office has breached section 10(1) of the FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires the Home Office to take the following step to ensure compliance with the legislation.
 - The Home Office must issue a substantive response to the request in accordance with its obligations under the FOIA.
- 4. The Home Office must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.

Request and response

5. On 28 April 2018, the complainant wrote to the Home Office and requested information in the following terms:



"Do targets for removals (whether voluntary or enforced) of individuals subject to immigration control form any of the performance measures which are the basis for calculation of Senior Civil Service pay?"

6. The Home Office wrote to the complainant on 1 June 2018 to confirm that the request was still being handled under the FOIA and apologised that it had not been able to respond within 20 working days. It stated that it would respond as soon as possible.

Scope of the case

- 7. The complainant contacted the Commissioner on 5 June 2018 to complain about the Home Office's failure to respond to his information request.
- 8. On 26 June 2018 the Commissioner wrote to the Home Office, reminding it of its responsibilities and asking it to provide a substantive response to the complainant within 10 working days.
- 9. Despite this intervention the Home Office has failed to respond to the complainant.

Reasons for decision

10. Section 1(1) of FOIA states that:

"Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him."
- 11. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt."
- 12. From the evidence provided to the Commissioner in this case, it is clear that the Home Office did not deal with the request for information in accordance with the FOIA. The Commissioner finds that the Home Office has breached section 10(1) by failing to respond to the request within



20 working days and it is now required to respond to the request in accordance with the FOIA.



Right of appeal

13. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
