

# Freedom of Information Act 2000 (FOIA) Decision notice

Date: 13 September 2018

**Public Authority:** Home Office

Address: 2 Marsham Street

London SW1P 4DF

## **Decision (including any steps ordered)**

- 1. The complainant requested information about financial bonuses paid to Home Office staff in relation to deportation targets.
- 2. The Commissioner's decision is that the Home Office has breached section 10(1) of the FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires the Home Office to take the following step to ensure compliance with the legislation.
  - The Home Office must issue a substantive response to the request in accordance with its obligations under the FOIA.
- 4. The Home Office must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.

### **Request and response**

5. On 27 April 2018, the complainant wrote to the Home Office and requested information in the following terms:



"I request pertinent information to financial bonuses or payments awarded to Home Office staff in relation to numbers of persons deported from the UK or otherwise sanctioned by home office decisions.

Additionally I request pertinent information to any financial bonuses or payments awarded to Home Office staff in relation to any targets relating to persons deported from the UK or otherwise sanctioned by home office decisions."

- 6. The Home Office acknowledged the request on the same day stating that it aimed to respond within 20 working days.
- 7. On 1 June 2018 the Home Office wrote to the complainant to confirm that they were still dealing with the request and to apologise for the delay, which it attributed to "internal delays with our FOI process".
- 8. The complainant requested an internal review on 15 June 2018 due to the ongoing delay. The Home Office responded on 25 June 2018, acknowledging that it had not complied with section 10 of the FOIA. It apologised for the further delay, but was unable to provide an exact timescale as to when its substantive response would be provided.

#### Scope of the case

- 9. The complainant contacted the Commissioner on 7 July 2018 to complain about the Home Office's failure to respond to his information request.
- 10. On 13 August 2018 the Commissioner wrote to the Home Office, reminding it of its responsibilities and asking it to provide a substantive response to the complainant within 10 working days.
- 11. Despite this intervention the Home Office has failed to respond to the complainant.

#### Reasons for decision

12. Section 1(1) of the FOIA states that:

"Any person making a request for information to a public authority is entitled –



- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him."
- 13. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt."
- 14. From the evidence provided to the Commissioner in this case, it is clear that the Home Office did not deal with the request for information in accordance with the FOIA. The Commissioner finds that the Home Office has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with the FOIA.



## Right of appeal

15. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
