

# Freedom of Information Act 2000 (FOIA) Decision notice

# **Decision (including any steps ordered)**

- 1. The complainant requested information regarding Hornsey Town Hall.
- 2. The Commissioner's decision is that the London Borough of Haringey ("the London Borough") failed to respond to the request within 20 working days and has therefore breached Section 10 of the FOIA.
- 3. The Commissioner requires the London Borough to take the following steps to ensure compliance with the legislation.
  - Issue a substantive response, under the FOIA, to the request which it gave the reference number LBH/7577418.
- 4. The London Borough must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the FOIA and may be dealt with as a contempt of court.

### **Request and response**

5. On 3 July 2018, the complainant wrote to the London Borough to request information. As the request was submitted via an online portal he does not have a copy of the precise request which was submitted



6. The London Borough wrote to the complainant later on the same day. It acknowledged that a request had been made and stated that the request would "be dealt with in accordance with the Freedom of Information Act 2000 / Environmental Information Regulations." It also provided a request reference number of LBH/7577418 but had failed to provide a substantive response by the date of this notice.

## Scope of the case

- 7. The complainant contacted the Commissioner on 11 August 2018 to complain about the failure, by the London Borough, to respond to the request.
- 8. In line with her usual practice, the Commissioner contacted the London Borough on 28 August 2018 to highlight the outstanding response. She requested that the London Borough respond to the request within 10 working days. The correspondence was neither acknowledged nor responded to.
- 9. The Commissioner considers that the fact that this response remains outstanding, despite her intervention, means that a decision notice is appropriate in this particular case.
- 10. The scope of this notice and the following analysis is to consider whether the London Borough has complied with Section 10 of the FOIA.

### Reasons for decision

11. Section 1(1) of the FOIA states that:

Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him.
- 12. Section 8(1) of the FOIA states:

In this Act any reference to a "request for information" is a reference to such a request which –

(a) is in writing,



- (b) states the name of the applicant and an address for correspondence, and
- (c) describes the information requested.
- 13. The Commissioner considers that the request in question fulfilled these criteria and therefore constituted a valid request for recorded information under the FOIA.
- 14. Section 10 of the FOIA states that responses to requests made under the Act must be provided "promptly and in any event not later than the twentieth working day following the date of receipt."
- 15. From the evidence presented to the Commissioner in this case, it is clear that, in failing to issue a response to the request within 20 working days, the London Borough has breached Section 10 of the FOIA.



# Right of appeal

16. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
