

Freedom of Information Act 2000 (FOIA) Decision notice

Date: 30 April 2019

Public Authority: Home Office

Address: 2 Marsham Street

London SW1P 4DF

Decision (including any steps ordered)

- 1. The complainant requested information relating to immigration applications submitted to the Home Office.
- 2. The Commissioner's decision is that the Home Office has breached section 10(1) of the FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires the Home Office to take the following step to ensure compliance with the legislation.
 - The Home Office must issue a substantive response to the request in accordance with its obligations under the FOIA.
- 4. The Home Office must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.

Request and response

5. On 20 June 2018, the complainant wrote to the Home Office and requested information in the following terms:



"I want the information of all the [immigration] applications that have been submitted through Verax Solicitors to Home Office, specifically for the clients who are Vietnamese nationals."

- 6. The complainant contacted the Home Office on 13 September 2018 to chase a response to her request. The Home Office acknowledged the request on 3 October 2018 and stated that it aimed to provide a full response by 30 October 2018.
- 7. The complainant contacted the Home Office again on 2 and 20 November 2018 to chase the overdue response.
- 8. On 16 January 2019 the Home Office contacted the complainant to ask for clarification of the request. The complainant responded the following day, 17 January 2019, to provide the necessary clarification.
- 9. The complainant sent a further chaser on 8 February 2019, the Home Office responded on 12 February 2019 to apologise for the delay.
- 10. To date the Home Office has failed to provide a response.

Scope of the case

- 11. The complainant contacted the Commissioner on 3 December 2018 to complain about the Home Office's failure to respond substantively to her information request.
- 12. On 9 January 2019 the Commissioner wrote to the Home Office, reminding it of its responsibilities and asking it to provide a substantive response to the complainant within 10 working days. Despite this intervention the Home Office has failed to respond to the request.
- 13. The Commissioner has considered whether the Home Office has complied with its obligations in relation to the time for compliance at section 10(1) of the FOIA.

Reasons for decision

14. Section 1(1) of the FOIA states that:

"Any person making a request for information to a public authority is entitled –



- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him."
- 15. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt."
- 16. From the evidence provided to the Commissioner in this case, it is clear that the Home Office did not deal with the request for information in accordance with the FOIA. The Commissioner finds that the Home Office has breached section 10(1) by failing to respond substantively to the request within 20 working days and it is now required to respond to the request in accordance with the FOIA.



Right of appeal

17. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
