

Freedom of Information Act 2000 (FOIA)

Decision (including any steps ordered)

1. The complainant requested information regarding complaints made to Her Majesty's Courts and Tribunals Service (HMCTS) in relation to court security at Wimbledon Magistrate's Court.
2. The Commissioner's decision is that the Ministry of Justice (MOJ) has breached section 10(1) of the FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
3. The Commissioner requires the MOJ to take the following step to ensure compliance with the legislation.
 - The MOJ must issue a substantive response to the request in accordance with its obligations under the FOIA.
4. The MOJ must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.

Request and response

5. On 15 March 2019 the complainant wrote to the MOJ and requested information in the following terms:

"1) How many formally recorded complaints were made to HMCTS with regards to court security (or named court security officers) at Wimbledon Magistrates' Court in the last 12 months? (if you only hold monthly data, I'll take February 2018 to February 2019)

2) Please provide an anonymized copy of all the complaints under 1) above, together with the internal complaint file (ie. investigations, internal correspondence, outcome). Information that would directly affect security interests (and is not already in the public domain) can also be redacted. Information that relates to customer service standards cannot be redacted."

6. The MOJ acknowledged the request on 20 March 2019. However, to date it has not provided a substantive response to the request.

Scope of the case

7. The complainant contacted the Commissioner on 16 April 2019 to complain about the MOJ's failure to respond to his information request.
8. On 30 April 2019 the Commissioner wrote to the MOJ, reminding it of its responsibilities and asking it to provide a substantive response to the complainant within 10 working days.
9. Despite this intervention the MOJ has failed to respond to the complainant.
10. The Commissioner has considered whether the MOJ has complied with its obligations in relation to the time for compliance at section 10(1) of the FOIA.

Reasons for decision

11. Section 1(1) of the FOIA states that:

"Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and*
- (b) if that is the case, to have that information communicated to him."*

12. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and *"not later than the twentieth working day following the date of receipt."*
13. From the evidence provided to the Commissioner in this case, it is clear that the MOJ did not deal with the request for information in accordance with the FOIA. The Commissioner finds that the MOJ has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with the FOIA.

Right of appeal

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
