

# Freedom of Information Act 2000 (FOIA) Decision notice

## **Decision (including any steps ordered)**

1. The complainant requested information concerning the use of webcams in blackmail crimes recorded in the financial years 2017/18 and 2018/19.

- 2. The Commissioner's decision is that Leicestershire Police has breached section 10(1) of the FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires Leicestershire Police to take the following step to ensure compliance with the legislation.
  - Leicestershire Police must provide a substantive response to the request in accordance with its obligations under the FOIA.
- 4. Leicestershire Police must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.

#### **Request and response**

5. On 9 May 2019, the complainant wrote to Leicestershire Police and requested information in the following terms:



"Under the Freedom of Information Act, could you provide me with the number of blackmail crimes, in each of the past two financial years (2017/18 and 2018/19), where a webcam has been involved in some way, i.e. where either webcam, web cam or video are mentioned in the summary of the report. Could you provide a summary of each report, including outcome, and state whether the alleged victim was aged under 16, 16 to 18 or over 18."

6. Leicestershire Police acknowledged the request on 9 May 2019 and once more on 13 May 2019. On 7 June 2019, the complainant contacted Leicestershire Police explaining that a response was still outstanding. Leicestershire Police apologised to the complainant for their delayed response on 10 June 2019. To date, a substantive response has not been issued.

## Scope of the case

- 7. The complainant contacted the Commissioner on 11 June 2019 to complain about Leicestershire Police's failure to respond to her request.
- 8. The Commissioner has considered whether Leicestershire Police has complied with its obligations in relation to the time for compliance at section 10(1) of the FOIA.

#### Reasons for decision

9. Section 1(1) of the FOIA states that:

"Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him."
- 10. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".
- 11. On 20 June 2019 the Commissioner wrote to Leicestershire Police reminding it of its responsibilities and asking it to provide a substantive response to the complainant within 10 working days.



12. Despite this intervention Leicestershire Police has failed to respond to the complainant.

13. From the evidence provided to the Commissioner in this case, it is clear that Leicestershire Police did not deal with the request for information in accordance with the FOIA. The Commissioner finds that Leicestershire Police has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with the FOIA.



## Right of appeal

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
