

# Freedom of Information Act 2000 (FOIA) Decision notice

Date: 15 October 2019

Public Authority: Darlington Borough Council Address: Town Hall Darlington DL1 5QT

### Decision (including any steps ordered)

- 1. The complainant requested information from Darlington Borough Council ("the Council") about home education and the education of Gypsy, Roma and Traveller children.
- 2. The Commissioner's decision is that the Council breached section 10(1) of the FOIA, since it did not respond to the request within the statutory time limit of 20 working days.
- 3. Since a response has now been issued, the Commissioner does not require the Council to take any steps.

#### **Request and response**

- 4. On 1 June 2017, the complainant wrote to the Council requesting information. The text of the request is set out in an annexe to this notice.
- 5. The Council responded on 17 June 2019, providing some information and also stating that some information was not held.



### Scope of the case

- 6. The complainant contacted the Commissioner on 25 June 2019 to complain about the way the request for information had been handled. Specifically, the complainant was concerned at the very long delay.
- 7. This notice considers the length of time taken by the Council to respond to the request.

### **Reasons for decision**

### Section 10 – time for compliance

8. Section 1(1) of the FOIA states that:

"Any person making a request for information to a public authority is entitled –

(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and

(b) if that is the case, to have that information communicated to him."

- 9. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt."
- 10. From the evidence provided to the Commissioner in this case, it is clear that the Council did not deal with the request for information in accordance with the FOIA. Indeed, as the Council has acknowledged, there was a two-year delay in issuing a response.
- 11. The Commissioner finds that the Council breached section 10(1) by failing to respond to the request within 20 working days. No steps are required in this case.

## **Other matters**

12. The Council agreed that the delay in this case was significant and unacceptable, and apologised that, during a period of staffing changes, the request had "fallen through the net". Despite the Council having apologised to the complainant and upholding a complaint, the Commissioner is concerned at the two-year delay, and has brought this matter to the attention of her Insight and Compliance team.



## **Right of appeal**

13. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
