Freedom of Information Act 2000 (FOIA) Decision notice

Decision (including any steps ordered)

1. The complainant requested information from Surrey Police about blackmail crimes.

- 2. The Commissioner's decision is that Surrey Police has breached section 10(1) of the FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires Surrey Police to take the following step to ensure compliance with the legislation.
 - Surrey Police must provide a substantive response to the request in accordance with its obligations under the FOIA.
- 4. Surrey Police must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.

Request and response

5. On 14 August 2019, the complainant wrote to Surrey Police following their internal review of a previous case which was referenced 002825/19 and requested information in the following terms:

"Would it be possible for you to send me summaries of a sample (say 20) of cases rather than all of them?"

6. Surrey Police did not acknowledge the request. To date, a substantive response has not been issued.

Scope of the case

- 7. The complainant contacted the Commissioner on 16 October 2019 to complain about Surrey Police's failure to respond to their request.
- 8. The Commissioner has considered whether Surrey Police has complied with its obligations in relation to the time for compliance at section 10(1) of the FOIA.

Reasons for decision

9. Section 1(1) of the FOIA states that:

"Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him."
- 10. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".
- 11. On 1 November 2019 the Commissioner wrote to Surrey Police, reminding it of its responsibilities and asking it to provide a substantive response to the complainant within 10 working days.
- 12. Despite this intervention Surrey Police has failed to respond to the complainant.
- 13. From the evidence provided to the Commissioner in this case, it is clear that Surrey Police did not deal with the request for information in accordance with the FOIA. The Commissioner finds that Surrey Police has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with the FOIA.
