

# Freedom of Information Act 2000 (FOIA) Decision notice

## **Decision (including any steps ordered)**

- 1. The complainant requested information from Ammanford Town Council ("the Council") relating to items of correspondence referred to in minutes.
- 2. The Commissioner's decision is that the Council failed to respond to the request within 20 working days and has therefore breached section 10 of the FOIA.
- 3. The Commissioner requires the Council to take the following step to ensure compliance with the legislation.
  - Issue a substantive response, under the FOIA, to the request.
- 4. The Council must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the FOIA and may be dealt with as a contempt of court.

#### **Request and response**

5. On 19 December 2019, the complainant wrote to the Council via the website What Do They Know<sup>1</sup> and requested information in the following terms:

"The Draft Minutes for the Full Council meeting held on 9th December 2019 (Draft-Minutes-Full-Council-09.12.2019.pdf) show eight pieces of correspondence had been received that required a response from the Council.

Please can you provide the date of each piece of correspondence, namely those referenced in:

6.1, 6.2, 6.3, 6.4, 6.5, 6.6, 6.7, 6.8"

6. The Council had failed to provide a substantive response by the date of this notice.

### Scope of the case

- 7. The complainant contacted the Commissioner on 23 January 2020 to complain about the failure by the Council to respond to the request.
- 8. In line with her usual practice, the Commissioner contacted the Council on 8 February 2020 to highlight the outstanding response. She requested that the Council respond to the request within 10 working days. The correspondence was neither acknowledged nor responded to.
- 9. The complainant contacted the Commissioner on 24 February 2020 to request a decision notice considering the Council's compliance with the FOIA.
- 10. The scope of this notice and the following analysis is to consider whether the Council complied with section 10 of the FOIA.

#### Reasons for decision

11. Section 1(1) of the FOIA states that:

Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him.



12. Section 8(1) of the FOIA states:

In this Act any reference to a "request for information" is a reference to such a request which –

- (a) is in writing,
- (b) states the name of the applicant and an address for correspondence, and
- (c) describes the information requested.
- 13. The Commissioner considers that the request in question fulfilled these criteria and therefore constituted a valid request for recorded information under the FOIA.
- 14. Section 10 of the FOIA states that responses to requests made under the Act must be provided "promptly and in any event not later than the twentieth working day following the date of receipt."
- 15. From the evidence presented to the Commissioner in this case, it is clear that, in failing to issue a response to the request within 20 working days, the Council has breached section 10 of the FOIA.
- 16. She requires the Council to issue a substantive response, which complies with the requirements of the FOIA, to the request.



# Right of appeal

17. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
