

# Freedom of Information Act 2000 (FOIA) Decision notice

#### **Decision (including any steps ordered)**

- 1. The complainant requested information regarding the availability of specialist psychiatric beds for young people with eating disorders. The NHS Commissioning Board (NHS England) acknowledged the request on 23 March 2021 but had failed to provide a substantive response by the date of this notice.
- 2. The Commissioner's decision is that NHS England failed to respond to the request within 20 working days and has therefore breached section 10 of the FOIA.
- 3. The Commissioner requires NHS England to take the following steps to ensure compliance with the legislation.
  - Issue a substantive response, in accordance with its obligations under the FOIA, to the request.
- 4. NHS England must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the FOIA and may be dealt with as a contempt of court.



#### **Request and response**

5. On 23 March 2021, the complainant wrote to NHS England and requested information in the following terms:

"Dear NHS England

Please provide information about:

- 1. How many specialist (tier 4) psychiatric beds were available to young people (12-18yrs) in England (ie free/unoccupied and ready to be taken up) in the week ending 19.3.21 (or week ending in that period).
- And (a) how many of those beds were specialist beds in eating disorder units;
- (b) how many of those beds were in general psychiatric units which can treat eating disorders;
- (c) how many of those beds in (a) or (b) were available to patients with ng tubes (since units are not able to have 100% of patients on ng feeding).
- 2. Please break down these numbers by geographic area.
- 3. Please also provide numbers of young people (12-18) in England waiting for a teir 4 eating disorder bed in that same period.

And break down those numbers by

- (a) geographical area
- (b) patients waiting in a general hospital
- (c) patients waiting in the community /at home
- (d) requiring tube feeding.
- 4. Please provide numbers of young people admitted to a tier 4 eating disorder unit in that same week, again with geographical breakdown. And number on ng feeding.
- 5. Please provide numbers of young people admitted to a tier 4 general psychiatric unit for the treatment of an eating disorder in that same week, again with geographical breakdown. And number on ng feeding.



6. Please provide the same information for the week 6 months previous and 12 months previous.

I look forward to your response."

6. NHS England acknowledged the request on 23 March 2021 but had failed to provide a substantive response by the date of this notice.

### Scope of the case

- 7. The complainant contacted the Commissioner on 22 April 2021 to complain about the failure, by NHS England, to respond to the request.
- 8. In line with her usual practice, the Commissioner contacted NHS England on 20 May 2021 to highlight the outstanding response. She requested that NHS England respond to the request within 10 working days.
- 9. The scope of this notice and the following analysis is to consider whether NHS England has complied with section 10 of the FOIA.

#### Reasons for decision

10. Section 1(1) of the FOIA states that:

Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him.
- 11. Section 10 of the FOIA states that responses to requests made under the Act must be provided "promptly and in any event not later than the twentieth working day following the date of receipt."
- 12. From the evidence presented to the Commissioner in this case, it is clear that, in failing to issue a response to the request within 20 working days, NHS England has breached section 10 of the FOIA.

#### Other matters



13. The Commissioner wishes to place on record her understanding of the immense pressures placed on public authorities during the coronavirus pandemic. She is sympathetic to the difficult decisions such authorities must make, between prioritising front-line services and continuing to meet their obligations under the FOIA.



## Right of appeal

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
