Freedom of Information Act 2000 (FOIA) Decision notice

Decision (including any steps ordered)

- 1. The complainant requested information from the Department for Business, Energy and Industrial Strategy (BEIS) about coal consumption.
- 2. The Commissioner's decision is that BEIS breached section 10(1) of the FOIA by failing to provide a valid response to the request within the statutory time frame of 20 working days. No steps are required.

Request and response

3. On 9 April 2021, the complainant wrote to BEIS and requested information in the following terms:

"Please share any information you have relating to coal consumption by Port Talbot steelworks in Neath Port Talbot council area, South Wales (owned by TATA). This includes total quantities and origin of coal, if either or both is available."

4. BEIS responded to the request for information on 20 May 2021.

Scope of the case

- 5. The complainant contacted the Commissioner on 7 July 2021 to complain about BEIS' failure to respond to their request within the statutory time frame of the FOIA.
- 6. The Commissioner has considered whether BEIS has complied with its obligations in relation to the time for compliance at section 10(1) of the FOIA.

Reasons for decision

7. Section 1(1) of the FOIA states that:

"Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him."
- 8. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".
- 9. From the evidence provided to the Commissioner in this case, it is clear that BEIS did not deal with the request for information in accordance with the FOIA. The Commissioner finds that BEIS has breached section 10(1) by failing to respond to the request within 20 working days.
