

# **Environmental Information Regulations 2004 (EIR)**Decision notice

Date: 18 November 2021

**Public Authority:** The London Borough of Croydon

#### **Decision (including any steps ordered)**

- 1. The complainant requested information from the London Borough of Croydon ("the Council") relating to a specific planning application. By the date of this notice the Council had not issued a substantive response to this request.
- 2. The Commissioner's decision is that the Council has breached regulation 5(2) of the EIR in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires the Council to take the following step to ensure compliance with the legislation.
  - The Council must provide a substantive response to the request in accordance with its obligations under the EIR.
- 4. The Council must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.



#### Request and response

5. On 15 September 2021, the complainant wrote to the Council and requested information in the following terms:

"I note that 'retrospective' planning application 21/02186/NMA (validated 28 April 2021) is still AWAITING DECISION.

This application is described as a "Non-material amendment to planning permission ref. 20/00170/CONR ... (without compliance with conditions 1, 3, 4, 6 and 13 attached to reference number: 19/00828/CONR ". (The latest, relevant document added to the website was published on 23 July 2021).

Despite the apparent non-determination, works have been allowed to continue on Site and the flats are now being advertised for sale. [link redacted]

- +++ Please provide COPIES of any information relating to how the LPA has so far attempted to determine this outstanding application. The information provided should include but not be restricted to the following:
- + correspondence with the applicant, agent and/or their consultants (from April 2021 to date), and
- + [internal and external] consultation and any comments provided by consultees [statutory or otherwise] in the same period."
- 6. The Council wrote to the complainant on 17 September 2021 to acknowledge the request. By the date of this notice, the Council has not provided the complainant with a response to his request.

## Scope of the case

- 7. The complainant contacted the Commissioner on 31 October 2021 to complain about the Council's failure to respond to their request.
- 8. The Commissioner has considered whether the Council has complied with its obligations in relation to the time for compliance at regulation 5(2) of the EIR.



#### Reasons for decision

9. Regulation 5(1) of the EIR states that:

"a public authority that holds environmental information shall make it available on request."

10. Regulation 5(2) of the EIR states that:

"Information shall be made available under paragraph (1) as soon as possible and no later than 20 working days after the date of receipt of the request."

- 11. On 3 November 2021 the Commissioner wrote to the Council, reminding it of its responsibilities and asking it to provide a substantive response to the complainant's request within 10 working days.
- 12. Despite this intervention the Council has failed to respond to the complainant.
- 13. From the evidence provided to the Commissioner in this case, it is clear that the Council did not deal with the request for information in accordance with the EIR. The Commissioner finds that the Council has breached regulation 5(2) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with the EIR.



## Right of appeal

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
