

# Freedom of Information Act 2000 (FOIA) Decision notice

Date: 17 May 2021

**Public Authority:** Brighton and Hove City Council

## **Decision (including any steps ordered)**

- 1. The complainant requested information from Brighton and Hove City Council ("the Council") relating to the transfer of Mears in-house. By the date of this notice the Council had not provided a substantive response to the request.
- 2. The Commissioner's decision is that the Council has failed to respond to the request within 20 working days and has therefore breached section 10 of the FOIA.
- 3. The Commissioner requires the Council to take the following steps to ensure compliance with the legislation.
  - Issue a substantive response to the request in accordance with its obligations under the FOIA.
- 4. The Council must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.



## **Request and response**

5. On 11 September 2020, the complainant wrote to the Council and requested information in the following terms:

"Could I please be sent all correspondence between councillors, senior officers and the GMB in relation to the transfer of Mears in-house."

- 6. On 14 September 2020, the Council wrote to the complainant to ask her to clarify her request for information.
- 7. The complainant responded on 22 September 2020 and provided the Council with further information to clarify her request. The complainant stated the following:

"Could I have all correspondence between September 1, 2019 and today please?"

- 8. The Council wrote to the complainant to on 20 October 2020, 17 November 2020, 5 February 2021 and 8 March 2021 to provide her with updates on the status of her information request.
- 9. However, by the date of this notice the Council had not provided the complainant with a substantive response to her request.

#### Scope of the case

- 10. The complainant contacted the Commissioner 22 March 2021 to complain about the Council's failure to respond to her request.
- 11. The Commissioner contacted the Council on 22 April 2021 reminding it of its responsibilities and asking it to provide a substantive response to the complainant within 10 working days.
- 12. The Commissioner also contacted the complainant on 22 April 2021 to explain that the Council had been given 10 working days from that date within which to provide a response to their request.
- 13. The complainant has provided evidence that she has received an acknowledgement from the Council but, by the date of this notice, had not received a substantive response to her information request.
- 14. The scope of this notice and the following analysis is to consider whether the Council has complied with section 10 of the FOIA.



#### **Reasons for decision**

- 15. Section 10 of the FOIA states that:
  - Any person making a request for information to a public authority is entitled –
  - (a) To be informed in writing by the public authority whether it holds information of the description specified in the request, and
  - (b) If that is the case, to have that information communicated to him.
- 16. Section 10 of the FOIA states that responses to requests made under the Act must be provided, "promptly and in any event not later than the twentieth working day following the date of receipt."
- 17. The Council did not provide a substantive response to the request within 20 working days of receipt. Therefore, the Commissioner's decision is that the Council has breached section 10 of the FOIA.



# Right of appeal

18. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
