Decision

1. The Commissioner's decision is that the Canal and River Trust (CRT) does not hold the information requested.

Request and response

2. On 6 February 2022 the complainant made the following request for information under the FOIA:

"This is an urgent enquiry about the erection of scaffolding close to and above and against the supporting structure of the Salvage Turn Bridge near to the Cube building in Birmingham. It was only last week that 3 notices of yours that were affixed to the scaffolding despite the contract duration being stated as having begun on the 3 January 2022 and the scaffolding having been erected months before that. Also the notices refer to a site location plan being attached and yet no plan is attached. Please e mail me a copy of the submitted application and the missing plan and explain why you have not contacted persons who may have ownership rights in connection with the bridge. I have attached a photographs of one of your three identical notices."

3. The CRT responded on 1 April 2022 and stated:

"The land in question, where the scaffolding is situated is not Trust land and therefore, we are not responsible for the permitted works. The Trust did however permit on/over the tow path outside of Holiday Wharf. Therefore unfortunately we do not hold the information you are requesting."

Reasons for decision

- 4. This reasoning covers whether the PA stated correctly that it does not hold any information falling within the scope of the complainant's request.
- 5. The position of CRT is that it does not hold any information. As it is not responsible for the land in question, there is no reason why it would hold the requested information.
- 6. On this basis, the Commissioner's conclusion is that on the balance of probabilities the CRT does not hold the requested information.
