

# Freedom of Information Act 2000 (FOIA) Decision notice

22 June 2022

Public Authority: Address: Department of Health & Social Care (DHSC) 1<sup>st</sup> Floor North 39 Victoria Street London SW1H 0EU

## Decision (including any steps ordered)

- 1. The complainant requested information from the DHSC relating to communications to and from the permanent secretary regarding the Valneva Covid-19 vaccine. By the date of this notice the DHSC had not issued a substantive response to this request.
- The Commissioner's decision is that the DHSC has breached section 10(1) of FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires the DHSC to take the following step to ensure compliance with the legislation.
  - The DHSC must provide a substantive response to the request in accordance with its obligations under FOIA.
- 4. The DHSC must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of FOIA and may be dealt with as a contempt of court.



### Request and response

5. On 22 November 2021, the complainant wrote to the DHSC and requested information in the following terms:

"Please could you provide a copy of all communications to or from the permanent secretary at the Department of Health and Social Care (or his office), during the period 30 August 2021 to 30 September 2021 inclusive, which contain either or both of the words "Valneva" and "VLA2001" (spelled with any combination of upper-and lower-case letters)."

6. The DHSC acknowledged the request on 24 November 2021. To date, a substantive response has not been issued.

#### Scope of the case

- 7. The complainant contacted the Commissioner on 11 May 2022 to complain about the DHSC's failure to respond to their request.
- 8. The Commissioner has considered whether the DHSC has complied with its obligations in relation to the time for compliance at section 10(1) of FOIA.

#### **Reasons for decision**

9. Section 1(1) of FOIA states that:

"Any person making a request for information to a public authority is entitled –

(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and

(b) if that is the case, to have that information communicated to him."

- 10. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".
- 11. On 25 May 2022 the Commissioner wrote to the DHSC, reminding it of its responsibilities and asking it to provide a substantive response to the complainant's request within 10 working days.



- 12. Despite this intervention the DHSC has failed to respond to the complainant.
- 13. From the evidence provided to the Commissioner in this case, it is clear that the DHSC did not deal with the request for information in accordance with FOIA. The Commissioner finds that the DHSC has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with FOIA.



## **Right of appeal**

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
