

Freedom of Information Act 2000 (FOIA) Decision notice

Date: 31 May 2022

Public Authority: Three Rivers District Council

Decision (including any steps ordered)

- 1. The complainant requested information about correspondence by Council staff of ministers regarding housing number requirements. By the date of this notice, Three Rivers District Council ("the Council") had not issued a substantive response to this request.
- 2. The Commissioner's decision is that the Council has breached section 10(1) of FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires the Council to take the following step to ensure compliance with the legislation.
 - The Council must provide a substantive response to the request in accordance with its obligations under FOIA.
- 4. The Council must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of FOIA and may be dealt with as a contempt of court.



Request and response

5. On 9 March 2022, the complainant wrote to the Council and requested information in the following terms:

"Please would you supply me with copies of all correspondence (paper or electronic) to any government department or Minister from any member of Three Rivers staff or any Three Rivers councillor which mentions housing number requirement for Three Rivers. Please supply correspondence dating back to 1 March 2020.

We are seeking evidence which would support [NAME REDACTED]'s contention at the area forum that TRDC are 'constantly badgering' the government to reduce the target number of houses in Three Rivers."

6. To date, a substantive response has not been issued.

Scope of the case

- 6. The complainant contacted the Commissioner on 12 May 2022 to complain about the Council's failure to respond to their request.
- 7. The Commissioner has considered whether the Council has complied with its obligations in relation to the time for compliance at section 10(1) of FOIA.

Reasons for decision

8. Section 1(1) of FOIA states that:

"Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him."
- 9. Section 10(1) of FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".



- 10. On 13 May 2022 the Commissioner wrote to the Council, reminding it of its responsibilities and asking it to provide a substantive response to the complainant's request within 10 working days.
- 11. Despite this intervention the Council has failed to respond to the complainant.
- 12. From the evidence provided to the Commissioner in this case, it is clear that the Council did not deal with the request for information in accordance with FOIA. The Commissioner finds that the Council has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with FOIA.



Right of appeal

13. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
