

# Freedom of Information Act 2000 (FOIA) Decision notice

#### **Decision**

1. The complainant submitted five requests for information about service complaints, information requests and subject access requests that they had previously submitted to the public authority. With regard to the four requests the authority handled under FOIA, on the balance of probabilities the authority has disclosed all the relevant information it holds and complied with section 1(1) of FOIA. The remaining relevant information is already reasonably accessible to the complainant and therefore exempt under section 21(1) of FOIA. The authority's response to one of the requests breached section 10(1) and section 17(1) as it was provided outside the required 20 working day timescale.

## **Request and response**

- 2. The complainant submitted a series of requests to the public authority from 25 January 2022 to 8 February 2022. These are reproduced in the appendix to this notice.
- 3. The public authority aggregated the five requests and responded to them together. It handled one of the requests under the data protection legislation. It advised that the complainant already had access to some of the information requested in the remaining four FOIA requests. The authority disclosed further information and provided links to where more general information is published.



#### Reasons for decision

- 4. Based on the complainant's complaint to the Commissioner, this reasoning covers whether the authority holds any further information within scope of the four requests it handled under FOIA. It also covers whether some information is exempt from disclosure under section 21 of FOIA. Finally the Commissioner will consider the timeliness of the authority's response.
- 5. Under section 1(1) of FOIA a public authority must communicate information to an applicant on request if it holds the information and it is not exempt from disclosure. Under section 10(1) the authority must comply with section 1 within 20 working days of a request. Within the same timescale under section 17(1) of FOIA the authority must issue a refusal notice in respect of any exempt information.
- 6. Information is exempt from disclosure under section 21 of FOIA if it is already reasonably accessible to the applicant.
- 7. The authority in this case handled one of the requests (its reference IC-154697-M7S8) under the data protection legislation. The remaining four FOIA requests also concern the complainant's own interactions with the public authority. The authority advised that, as such, they could already access some of that information for example, their own correspondence with the authority. However, the authority provided other relevant information and links to where more general information that the complainant might find useful is published.
- 8. In the absence of any evidence from the complainant to suggest otherwise, the Commissioner accepts that the authority holds no further information within scope of the complainant's four requests, that the complainant does not already have access to. Information the complainant does already have access to is exempt information under section 21 of FOIA.
- 9. The Commissioner also considers that the authority's handling of the requests aggregating them and handling them together was entirely reasonable and proportionate. However, the authority provided its single response on 28 February 2022 and, as such, did not comply with section 10(1) or section 17(1) in respect of the request of 25 January 2022.
- 10. Finally, he agrees that the authority was correct to handle the requests under FOIA and not the Environmental Information Regulations as none of the requested information is environmental information.



## Right of appeal

11. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
