

Freedom of Information Act 2000 (FOIA) Decision notice

Decision (including any steps ordered)

- 1. The complainant requested information from Nottinghamshire Police relating to problem profile assessments produced or commissioned by the public authority. By the date of this notice Nottinghamshire Police had not issued a substantive response to this request.
- 2. The Commissioner's decision is that Nottinghamshire Police has breached section 10(1) of FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires Nottinghamshire Police to take the following step to ensure compliance with the legislation.
 - Nottinghamshire Police must provide a substantive response to the request in accordance with its obligations under FOIA.
- 4. Nottinghamshire Police must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of FOIA and may be dealt with as a contempt of court.



Request and response

5. On 25 April 2022, the complainant wrote to Nottinghamshire Police and requested information in the following terms:

"Please provide a list of the titles of all problem profile assessments produced or commissioned by your police force on the following crime area from 1st January 2018 to the date of this request.

- -Domestic abuse
- -Modern slavery
- -Violence against women and girls
- -Rape and sexual offences

Guidance on what constitutes a problem profile is provided by the College of Policing here.

If providing a comprehensive list for the entire force would breach the cost limit, I would be happy to limit my request to force wide profiles held centrally.

Please send me this information by e-mail to [redated], in a machine readable format such as .csv or .xlsx where appropriate.

If you have any queries about this request please contact me on [redacted].

If you are encountering practical difficulties complying with this request, please contact me so that we can discuss the matter and if necessary I can modify the request."

6. To date, a substantive response has not been issued.

Scope of the case

- 7. The complainant contacted the Commissioner on 28 July 2022 to complain about Nottinghamshire Police's failure to respond to their request.
- 8. The Commissioner has considered whether Nottinghamshire Police has complied with its obligations in relation to the time for compliance at section 10(1) of FOIA.



Reasons for decision

9. Section 1(1) of FOIA states that:

"Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him."
- 10. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".
- 11. On 2 August 2022 the Commissioner wrote to Nottinghamshire Police, reminding it of its responsibilities and asking it to provide a substantive response to the complainant's request within 10 working days.
- 12. Despite this intervention Nottinghamshire Police has failed to respond to the complainant.
- 13. From the evidence provided to the Commissioner in this case, it is clear that Nottinghamshire Police did not deal with the request for information in accordance with FOIA. The Commissioner finds that Nottinghamshire Police has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with FOIA.



Right of appeal

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
