Freedom of Information Act 2000 (FOIA) Decision notice

Date: 20 September 2022

Public Authority: Oxfordshire County Council

Decision (including any steps ordered)

- 1. The complainant requested information from Oxfordshire County Council ("OCC") relating to FOI breaches. By the date of this notice OCC had not issued a substantive response to this request.
- 2. The Commissioner's decision is that OCC has breached section 10(1) of FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires OCC to take the following step to ensure compliance with the legislation.
 - OCC must provide a substantive response to the request in accordance with its obligations under FOIA.
- 4. OCC must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of FOIA and may be dealt with as a contempt of court.

Request and response

5. On 30 May 2022, the complainant wrote to OCC and requested information in the following terms:

Reference: IC-189157-K2C3



"In doing so now, might I also request data on the number of breaches of the FOI Act that have occurred in the past twelve months, namely the number of requests made and not acknowledged, nor processed within the 20-day time scale."

6. To date, a substantive response has not been issued.

Scope of the case

- 7. The complainant contacted the Commissioner on 18 August 2022 to complain about OCC's failure to respond to their request.
- 8. The Commissioner has considered whether OCC has complied with its obligations in relation to the time for compliance at section 10(1) of FOIA.

Reasons for decision

9. Section 1(1) of FOIA states that:

"Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him."
- 10. Section 10(1) of FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".
- 11. On 31 August 2022 the Commissioner wrote to OCC, reminding it of its responsibilities and asking it to provide a substantive response to the complainant's request within 10 working days.
- 12. Despite this intervention OCC has failed to respond to the complainant.
- 13. From the evidence provided to the Commissioner in this case, it is clear that OCC did not deal with the request for information in accordance with FOIA. The Commissioner finds that OCC has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with FOIA.
