

Environmental Information Regulations 2004 (EIR) Decision notice

Date: 5 October 2022

Public Authority: Rugby Borough Council

Decision (including any steps ordered)

- 1. The complainant requested information in relation to the handling of a planning application. By the date of this notice Rugby Borough Council ("the Council") had not issued a substantive response to this request.
- 2. The Commissioner's decision is that the Council has failed to respond to the request within 20 working days and has therefore breached regulation 5(2) of the EIR.
- 3. The Commissioner requires the Council to take the following steps to ensure compliance with the legislation.
 - Issue a substantive response to the request in accordance with its obligations under the EIR.
- 4. The Council must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Freedom of Information Act and may be dealt with as a contempt of court.



Request and response

5. On 29 July 2022, the complainant wrote to the Council and requested information in the following terms:

"Freedom of Information request this relates (directly and indirectly) to the genesis and subsequent handling of planning application [redacted])

- 1. Were any site visits/inspections whatsoever carried out that were relevant to the assessment/processing of this application?
- 2. If the answer to 1. is 'yes', on what date(s) were they carried out?
- 3. In each case, what was/were the address(es) of the properties visited?
- 4. Copy of any notes made arising from the visits.

Please note: I'm very happy for the actual name(s) of any individual officer to be 'redacted' (if you so wish) because I am concerned here only with the council's 'procedures' not those of an individual. There should be no other deletions."

6. The Council acknowledged the request on the same date. To date, a substantive response to the request has not been issued.

Scope of the case

- 7. The complainant contacted the Commissioner on 5 September 2022 to complain about the Council's failure to respond to this request.
- 8. The Commissioner contacted the Council on 14 September 2022 reminding it of its responsibilities and asking it to provide a substantive response to the complainant within 10 working days.
- 9. Despite this intervention the Council has failed to respond to the complainant.
- 10. The scope of this notice and the following analysis is to consider whether the Council has complied with regulation 5(2) of the EIR.

Reasons for decision

11. Regulation 5(1) of the EIR states that:



"a public authority that holds environmental information shall make it available on request."

12. Regulation 5(2) of the EIR states that:

"Information shall be made available under paragraph (1) as soon as possible and no later than 20 working days after the date of receipt of the request."

13. From the evidence provided to the Commissioner in this case, it is clear that the Council did not deal with the request for information in accordance with the EIR. The Commissioner's decision is that the Council has breached regulation 5(2) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with the EIR.



Right of appeal

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
