

Freedom of Information Act 2000 (FOIA) Decision notice

Date: 24 November 2022

Public Authority: HM Treasury

Decision (including any steps ordered)

- 1. The complainant requested information relating to the minutes and any preparatory notes for a meeting between Elizabeth Truss and FTI Consulting. By the date of this notice HM Treasury had not issued a substantive response to this request.
- 2. The Commissioner's decision is that HM Treasury has breached section 10(1) of FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires HM Treasury to take the following step to ensure compliance with the legislation.
 - HM Treasury must provide a substantive response to the request in accordance with its obligations under FOIA.
- 4. HM Treasury must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of FOIA and may be dealt with as a contempt of court.

Request and response

5. On 29 September 2022, the complainant wrote to HM Treasury and requested information in the following terms:



"I would like to request, under FOI regulations, minutes and any preparatory notes for the following meeting:

- 1. 30/01/2019 between Elizabeth Truss and FTI Consulting."
- 6. HM Treasury acknowledged the request on 29 September 2022. To date, a substantive response has not been issued.

Scope of the case

- 7. The complainant contacted the Commissioner on 31 October 2022 to complain about HM Treasury's failure to respond to their request.
- 8. The Commissioner has considered whether HM Treasury has complied with its obligations in relation to the time for compliance at section 10(1) of FOIA.

Reasons for decision

9. Section 1(1) of FOIA states that:

"Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him."
- 10. Section 10(1) of FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".
- 11. On 8 November 2022 the Commissioner wrote to HM Treasury, reminding it of its responsibilities and asking it to provide a substantive response to the complainant's request within 10 working days.
- 12. Despite this intervention HM Treasury has failed to respond to the complainant.
- 13. From the evidence provided to the Commissioner in this case, it is clear that HM Treasury did not deal with the request for information in accordance with FOIA. The Commissioner finds that HM Treasury has breached section 10(1) by failing to respond to the request within 20



working days and it is now required to respond to the request in accordance with FOIA.



Right of appeal

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
