

Freedom of Information Act 2000 (FOIA) Decision notice

Date: 27 January 2022

Public Authority: Northumberland County Council

Decision (including any steps ordered)

- 1. The complainant requested information about proposed residents parking schemes for Union Street, Blyth. By the date of this notice, Northumberland County Council ("the Council") had not issued a substantive response to this request.
- 2. The Commissioner's decision is that the Council has breached section 10(1) of the FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires the Council to take the following step to ensure compliance with the legislation.
 - The Council must provide a substantive response to the request in accordance with its obligations under the FOIA.
- 4. The Council must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.



Request and response

- 5. On 20 August 2021, the complainant wrote to the Council and requested information in the following terms:
 - "I would be grateful if you would provide me with
 - 1) Details of any correspondence between elected members and officers concerning residents parking schemes for Union Street, Blyth between the period 1st January 2019 and 5th May 2021,
 - 2) Copies of any such correspondence, including plans or descriptions of the work proposed, and
 - 3) Details of any correspondence between elected members and officers, including copies of the correspondence or background work undertaken, for the same period concerning any financial preparations for a residents parking scheme on Union Street, Blyth."
- 6. The Council acknowledged the request on 20 August 2021. To date, a substantive response to the request has not been issued.

Scope of the case

- 7. The complainant contacted the Commissioner on 9 December 2021, to complain about the Council's failure to respond to their request.
- 8. The Commissioner has considered whether the Council has complied with its obligations in relation to the time for compliance at section 10(1) of the FOIA.

Reasons for decision

9. Section 1(1) of the FOIA states that:

"Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him."
- 10. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".



- 11. On 4 January 2022, the Commissioner wrote to the Council, reminding it of its responsibilities and asking it to provide a substantive response to the complainant's request within 10 working days.
- 12. Despite this intervention, the Council has failed to respond to the complainant.
- 13. From the evidence provided to the Commissioner in this case, it is clear that the Council did not deal with the request for information in accordance with the FOIA. The Commissioner finds that the Council has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with the FOIA.



Right of appeal

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
