

Freedom of Information Act 2000 (FOIA) Decision notice

Decision (including any steps ordered)

- The complainant requested information from Black Country Healthcare NHS Foundation Trust ("the Trust") relating to information requests the Trust has received which concern interpreting and translation services. By the date of this notice the Trust had not issued a substantive response to this request.
- 2. The Commissioner's decision is that the Trust has breached section 10(1) of the FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires the Trust to take the following step to ensure compliance with the legislation.
 - The Trust must provide a substantive response to the request in accordance with its obligations under the FOIA.
- 4. The Trust must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.



Request and response

5. On 8 December 2021, the complainant wrote to the Trust and requested information in the following terms:

"I would like to submit an FOI request regarding all responses provided to previous FOIs requests in relation to translation or interpreting services for the legacy Black Country Partnership NHS Trust starting with April 2016 and until the present date.

If you have a disclosure log available online (I could not find one), can you please provide a link to it so I can have a look and see if there is any data that I could use?

As you might know, I'm trying to find out how much the Trust (and the previous legacy Trusts) has spent between 2015/2016-2019/2020 on such services."

6. The Trust wrote to the complainant on 9 December 2021 to acknowledge the request. By the date of this notice, the Trust has not provided the complainant with a substantive response to their request.

Scope of the case

- 7. The complainant contacted the Commissioner on 12 January 2022 to complain about the Trust's failure to respond to their request.
- 8. The Commissioner has considered whether the Trust has complied with its obligations in relation to the time for compliance at section 10(1) of the FOIA.

Reasons for decision

9. Section 1(1) of the FOIA states that:

"Any person making a request for information to a public authority is entitled –

(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and

(b) if that is the case, to have that information communicated to him."



- 10. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".
- 11. On 21 January 2022 the Commissioner wrote to the Trust, reminding it of its responsibilities and asking it to provide a substantive response to the complainant's request within 10 working days.
- 12. Despite this intervention, the Trust has failed to respond to the complainant.
- 13. From the evidence provided to the Commissioner in this case, it is clear that the Trust did not deal with the request for information in accordance with the FOIA. The Commissioner finds that the Trust has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with the FOIA.



Right of appeal

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
