

Freedom of Information Act 2000 (FOIA) Decision notice

Public Authority: Address: Kellogg College, University of Oxford 60-62 Banbury Rd Park Town Oxford OX2 6PN

Decision (including any steps ordered)

- 1. The complainant requested information from Kellogg College about British Muslim recruitment. By the date of this notice Kellogg College had not issued a substantive response to this request.
- 2. The Commissioner's decision is that Kellogg College has breached section 10(1) of FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires Kellogg College to take the following step to ensure compliance with the legislation.
 - Kellogg College must provide a substantive response to the request in accordance with its obligations under FOIA.
- 4. Kellogg College must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of FOIA and may be dealt with as a contempt of court.



Request and response

5. On 1 February 2022, the complainant wrote to Kellogg College and requested information in the following terms:

"Dear Kellogg College, Oxford,

1. How many British Muslim employees have you recruited? Please provide figures for every year since 2010.

2. What is the average length of service?

3. How many British Muslims have you employed in communications/media roles since 2010?"

6. Kellogg College acknowledged the request on 2 March 2022. To date, a substantive response has not been issued.

Scope of the case

- 7. The complainant contacted the Commissioner on 2 March 2022 to complain about Kellogg College's failure to respond to their request.
- The Commissioner has considered whether Kellogg College has complied with its obligations in relation to the time for compliance at section 10(1) of FOIA.

Reasons for decision

9. Section 1(1) of FOIA states that:

"Any person making a request for information to a public authority is entitled –

(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and

(b) if that is the case, to have that information communicated to him."

 Section 10(1) of the FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".



- 11. On 9 March 2022 the Commissioner wrote to Kellogg College, reminding it of its responsibilities and asking it to provide a substantive response to the complainant's request within 10 working days.
- 12. Despite this intervention Kellogg College has failed to respond to the complainant.
- 13. From the evidence provided to the Commissioner in this case, it is clear that Kellogg College did not deal with the request for information in accordance with FOIA. The Commissioner finds that Kellogg College has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with FOIA.



Right of appeal

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
