

# Freedom of Information Act 2000 (FOIA) Decision notice

#### Decision (including any steps ordered)

- 1. The complainant requested information regarding public sector professional courses attracting an enhanced DBS check. By the date of this notice UCAS had not issued a substantive response to this request.
- 2. The Commissioner's decision is that UCAS has breached section 10(1) of FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires UCAS to take the following step to ensure compliance with the legislation.
  - UCAS must provide a substantive response to the request in accordance with its obligations under FOIA.
- 4. UCAS must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of FOIA and may be dealt with as a contempt of court.

#### **Request and response**

5. On 4 June 2021, the complainant wrote to UCAS and requested information in the following terms:



"Please would it be possible to know:

1) number of applicants to enhanced DBS attracting courses (I saw 1% mentioned but not a figure).

2) number of applicants to social work courses

3) number of applicants to social work courses self-identifying as having a criminal record (by total number and by gender, age, ethnicity and care leaver characteristics).

4) number of applicants with criminal records applying to social work courses who received offers (conditional or unconditional).

Inclusion criteria: 3) Timeframe 2019/2020 application round. 4) England resident applicants only."

6. UCAS acknowledged the request on 7 June 2021. To date, a substantive response has not been issued.

## Scope of the case

- 7. The complainant contacted the Commissioner on 25 April 2022 to complain about UCAS's failure to respond to their request.
- The Commissioner has considered whether UCAS has complied with its obligations in relation to the time for compliance at section 10(1) of FOIA.

### Reasons for decision

9. Section 1(1) of FOIA states that:

"Any person making a request for information to a public authority is entitled –

(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and

(b) if that is the case, to have that information communicated to him."

- 10. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".
- 11. On 22 March 2022 the Commissioner wrote to UCAS, reminding it of its responsibilities and asking it to provide a substantive response to the complainant's request within 10 working days.



- 12. Despite this intervention UCAS has failed to respond to the complainant.
- 13. From the evidence provided to the Commissioner in this case, it is clear that UCAS did not deal with the request for information in accordance with FOIA. The Commissioner finds that UCAS has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with FOIA.



## **Right of appeal**

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
