

Freedom of Information Act 2000 (FOIA) Decision notice

Decision (including any steps ordered)

- The complainant has requested information with regards to properties inherited from one previous council to another. Dorset Council (the council) provided some information and applied section 21 of FOIA to other information, as it determined it was reasonably accessible from the links it provided. The complainant considered that the council held more information.
- 2. The Commissioner's decision is that, on the balance of probabilities, the council has provided the information it holds.
- 3. The Commissioner does not require the council to take any steps.



Request and response

4. On 11 April 2022 the complainant made the following information request to the council:

"I specifically request to know the locations of all the archives that hold the details of properties once owned by Lyme Regis Borough Council which West Dorset District Council inherited in the local government reorganisation in 1974 and the recent reorganisation when they were transferred from West Dorset District Council to the newly formed Dorset Council but not including those transferred to the Dorset History Centre?

Also under the same acts I request a copy of the index/catalogue to these archives and a copy of the Borough Housing and Estates Committee minutes missing from the Lyme Regis Town Council office. These missing minutes include:

- 5. The council responded on 9 May 2022. It provided the complainant with a list of properties with Land Registry Title Numbers and the location of the deeds.
- 6. The council also applied section 21 of FOIA to part of the request information reasonably accessible, and provided the complainant with a link to:
 - the Land Registry website where the register entries and title plans can be obtained.
 - A webpage which details what is held at Dorset History Centre.
- 7. The council also stated that ownership of some properties may have been transferred from Lyme Regis Borough Council to Lyme Regis Town Council, and it recommended that the complainant contact the latter directly.
- 8. The complainant requested an internal review on 6 June 2022, raising three issues with the council's response to their request.
- 9. The council provided its internal review on 30 June 2022. It addressed each of the complainant's three points individually:
 - "I specifically requested to know the location of all the archives (Dorset Council store/strong rooms) that hold the details of properties once owned by Lyme Regis Borough Council and not transferred to the Dorset History Centre."

The council responded advising that the documents in County Hall are held in a cabinet in the Legal Services office. It was unable advise how Iron Mountain store their records, but provided a link to Iron Mountains website where this information can be found.

2. "I also specifically requested a copy of the index/catalogue to these archives (the index/catalogue for all documentation held in Dorset Council store/strong rooms)."

The council responded to advise that this information was not held.

3. "I also specifically requested copies of the Lyme Regis Borough Housing and Estates Committee minutes removed from the Lyme Regis Town Council Office which you hold as evidenced on page 5 of the Cobbgate Incident attachment."



The council responded to say that whilst it previously had advised that minutes were available at Dorset History Centre, it did not provide an appropriate link which would enable the complainant to view/ gain access to copies. It then provided a link to Dorset History Centres copying service on the council's website.

The council also advised that the remaining minutes (between 1961 to April 1971) are not held, and advised that Lyme Regis Town Council may hold them.

10. On 15 July 2022, the council then located and provided the complainant with the indexes of deed packets.

Scope of the case

- 11. The complainant contacted the Commissioner on 15 August 2022. He is not disputing the council's application of section 21 of FOIA, but he still considers further information is held by the council that has not been provided to him.
- 12. The scope of the case is for the Commissioner to determine whether the council has provided all of the information it holds falling within the scope of the request.

Reasons for decision

Section 1 of the FOIA - Information held/ not held

- 13. Section 1 of FOIA states that any person making a request for information to a public authority is entitled to be informed in writing by the public authority whether it holds information within the scope of the request, and if so, to have that information communicated to him.
- 14. Where there is some dispute between the amount of information identified by a public authority and the amount of information that a complainant believes may be held, the Commissioner, following the lead of a number of Fist-tier Tribunal decisions must decide whether, on the civil standard of the balance of probabilities, the public authority holds any information which falls within the scope of the request (or was held at the time of the request).
- 15. The council has told the Commissioner that its Democratic Services, and the Dorset History Centre teams within the council, were contacted to establish what information was held.



- 16. The council has also advised that if further information were held, it would be stored manually as paper records. It has confirmed that the information would not have been digitised.
- 17. The council has also stated that it has already advised the complainant that further information may be held by Lyme Regis Town Council, and has explained the reasons for this to him.
- 18. The council has confirmed to the Commissioner that the minutes of local authority committee meetings are generally preserved permanently as a record of decision making. However, it goes on to say that as some of the requested information pre dates the Local Government Act 1972, which placed a duty on local authorities to manage records effectively, this may explain the lack of comprehensive records of Lyme Regis Borough Council minutes that predate 1972.
- 19. The Commissioner has reviewed the council's response and the explanations provided as to why additional information is not held; he is satisfied the council has taken reasonable and proportionate steps to establish what information is held.
- 20. Based on the above, the Commissioner finds, on the balance of probabilities, that the council holds no further information falling within the scope of the request.



Right of appeal

21. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
