

# Freedom of Information Act 2000 (FOIA) Decision notice

## Decision (including any steps ordered)

- 1. The complainant requested information from Cambridge University Hospitals NHS Foundation Trust ("the Trust") about diagnostic nerve procedures. By the date of this notice the Trust had not issued a substantive response to this request.
- The Commissioner's decision is that the Trust has breached section 10(1) of FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires the Trust to take the following step to censure compliance with the legislation.
  - The Trust must provide a substantive response to the request in accordance with its obligations under FOIA.
- 4. The Trust must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of FOIA and may be dealt with as a contempt of court.



#### **Request and response**

5. On 29 July 2022, the complainant wrote to the Trust and requested information in the following terms:

"1. Has Addenbrooke's undertaken any temporary diagnostic nerve block procedure in the last 6 years to investigate any complaint? If so, how many procedures?

2. Has Addenbrooke's undertaken any temporary diagnostic nerve block procedure in the last 6 years to investigate male genital pain? If so, how many procedures?

3. Does any staff member in the urology department at Addenbrooke's have the expertise to conduct a temporary nerve block procedure to investigate unexplained testicular pain? (I understand that names may need to be withheld but please indicate role, rank or qualification.)

4. Does any staff member in the pain management or anaesthetics departments at Addenbrooke's have the expertise to conduct a temporary nerve block procedure to investigate unexplained testicular pain? (I understand that names may need to be withheld but please indicate role, rank or qualification.)

5. Does any staff member in any other department at Addenbrooke's have the expertise to conduct a temporary nerve block procedure to investigate unexplained testicular pain? (I understand that names may need to be withheld but please indicate role, rank or qualification.)

6. Does Addenbrooke's currently have the resources in terms of equipment, staff and expertise to conduct a temporary nerve block procedure to investigate unexplained testicular pain?

7. Has Addenbrooke's had the resources in terms of equipment, staff and expertise to conduct a temporary nerve block procedure to investigate unexplained testicular pain at any time since January 2020?"

6. The Trust acknowledged this request on 6 August 2022. To date, a substantive response has not been issued.



## Scope of the case

- 7. The complainant contacted the Commissioner on 14 September 2022 to complain about the Trust's failure to respond to their request.
- 8. The Commissioner has considered whether the Trust has complied with its obligations in relation to the time for compliance at section 10(1) of FOIA.

#### **Reasons for decision**

9. Section 1(1) of FOIA states that:

"Any person making a request for information to a public authority is entitled –

(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and

(b) if that is the case, to have that information communicated to him."

- 10. Section 10(1) of FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".
- 11. On 4 October 2022 the Commissioner wrote to the Trust, reminding it of its responsibilities and asking it to provide a substantive response to the complainant's request within 10 working days.
- 12. Despite this intervention the Trust has failed to respond to the complainant.
- 13. From the evidence provided to the Commissioner in this case, it is clear that the Trust did not deal with the request for information in accordance with FOIA. The Commissioner finds that the Trust has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with FOIA.



# **Right of appeal**

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
