

Freedom of Information Act 2000 (FOIA) Decision notice

Date: 6 March 2023

Public Authority: Goole Town Council Address: Paradise Place Goole DN14 5DL

Decision (including any steps ordered)

- 1. The complainant requested information about Victoria Pleasure Grounds. By the date of this notice, Goole Town Council ("the Council") had not issued a substantive response to this request.
- 2. The Commissioner's decision is that the Council has breached section 10(1) of FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires the Council to take the following step to ensure compliance with the legislation.
 - The Council must provide a substantive response to the request in accordance with its obligations under FOIA.
- 4. The Council must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of FOIA and may be dealt with as a contempt of court.

Request and response

5. On 24 August 2022, the complainant wrote to the Council and requested information in the following terms:

"I would like to see all documents relating to the future of the running track in the Victoria Pleasure Grounds - either links to relevant places on the GTC website where the specific meeting notes can be downloaded (rather than just a generic link - I've found where the minutes are on the website, but don't know which are the relevant minutes to look at),



or the documents themselves if they are not available on the website. I note the last minutes for a Town Council meeting are for May. If any documents are withheld, I would like to know what the documents pertain to, and why they are being withheld."

6. To date, a substantive response has not been issued.

Scope of the case

- 7. The complainant contacted the Commissioner on 1 December 2022 to complain about the Council's failure to respond to their request.
- The Commissioner has considered whether the Council has complied with its obligations in relation to the time for compliance at section 10(1) of FOIA.

Reasons for decision

9. Section 1(1) of FOIA states that:

"Any person making a request for information to a public authority is entitled –

(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and

(b) if that is the case, to have that information communicated to him."

- 10. Section 10(1) of FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".
- 11. On 9 February 2022 the Commissioner wrote to the Council reminding it of its responsibilities and asking it to provide a substantive response to the complainant's request within 10 working days.
- 12. Despite this intervention the Council has failed to respond to the complainant.
- 13. From the evidence provided to the Commissioner in this case, it is clear that the Council did not deal with the request for information in accordance with FOIA. The Commissioner finds that the Council has breached section 10(1) by failing to respond to the request within 20



working days and it is now required to respond to the request in accordance with FOIA.



Right of appeal

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
